In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for APPOINTMENT OF A PANEL OF A MAXIMUM OF FOUR (4) CONTRACTORS FOR THE SUPPLY, REPLACEMENT AND CONSTRUCTION OF WATER & SEWER NETWORKS IN STLM AREA FOR THREE (3) FINANCIAL YEARS AS AND WHEN REQUIRED, in the Steve Tshwete municipal region. **Tenderers should have a CIDB contractor grading of 4CE or Higher.**

Only payments made in cash or debit/credit card will be accepted.

Fully completed tender enclosed in a sealed envelope marked "TENDER NO. BS08/05/2026: APPOINTMENT OF A PANEL OF A MAXIMUM OF FOUR (4) CONTRACTORS FOR THE SUPPLY, REPLACEMENT AND CONSTRUCTION OF WATER & SEWER NETWORKS IN STLM AREA FOR THREE (3) FINANCIAL YEARS AS AND WHEN REQUIRED" with the name of the tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 1 st floor, Room B207, Civic Centre, Corner Walter Sisulu and Wanderers Avenue, Middelburg, before 12H00 on 07/07/2026. The tenders will be opened in public.

A **compulsory** clarification meeting will take place on 23/06/2026 starting at 10:00, at Electrical Boardroom, Municipal Service Centre (Magasyn), Corner Protea and Walter Sisulu Street, Middelburg, 1050

Bidders will be evaluated on functionality whereby 70 points has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of Specific Goals. Tenderers must have the necessary skills, experience and capacity to perform the required work.

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.
