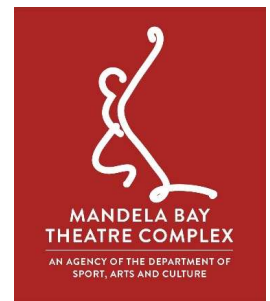

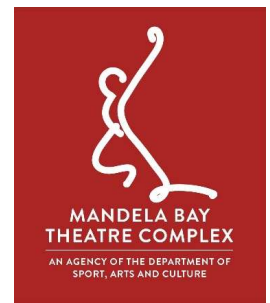

Electronics & Modern Technology

- **Smartphones:** Required for nearly all characters to exchange **QR codes**, "NameDrop" contacts, show **bank notifications** (EFTs), record TikToks, and view the "Thembu Lobola Committee" WhatsApp group.
- **Ring-light and Tripod:** Used by Mpho for filming social media content.

- **Glass Table:** Specifically used during the tea service where Mpho and Refilwe confront each other.
- **Plush Outdoor Sofa:** Where Mpho and Refilwe sit to exchange their social media handles via "NameDrop."

ACT III: THE LODGE LOUNGE

- **Plush Velvet Sofa:** Located inside the lounge where Mama Thembu sits to conduct her "preliminary inquiry."
- **Luxury Patio Chair:** A seat Jack "sinks back into" during his frustration with Lebohang.
- **Lounge Stairs:** Which Jack runs up "two at a time" to search for the Hermès handbag.
- **Wardrobe:** Mentioned as the source of noise when Jack is upstairs aggressively searching for his belongings.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.
