Tenderers are to note the following amendment to the tender documentation, which shall be deemed to be necessary changes to the tender documentation in this regard. All other tender documentation remains unchanged.

This addendum is to address the following issues identified at the briefing meeting and request received from bidders after the briefing meeting.

1. Corrections made on the tender document at the briefing meeting

- (i) Annexure B11 Traffic and Transportation Engineering, on page 125 of the tender document under item 3, scratch "material" and replace it with "Traffic". Everything else remains constant.
- (ii) **Annexure A5 Architectural Services,** on page 27 of the tender document, on the third line of the heading, scratch "C6" and replace it with "A5", this is a minor standardisation change, as all Technical/Functionality Evaluation Spreadsheets are referenced as **Annexure A**.
- (iii) **Annexure 14 & 15** which form part of the Technical/Functionality Evaluation were erroneously not included as part of the tender document pack and are now attached to this addendum and should be submitted with the bid when completed.

2. Change of number of years for project experience

Transnet received the request below from some bidders:

"Extension of project experience beyond 5 years to 10 years: in the past 5 years the economy was active for 3 years due to covid. Most strategic



projects were either cancelled or put on hold which significantly disadvantages most if not all industry participants. Please review."

In response to the above request, Transnet decided that the Project experience will be extended beyond 5 years to 8 years. You are therefore advised that any reference to **project experience of 5 years** on the tender document is now replaced by **project experience of 8 years.** This only applies to items 1.2, 1.3 and 1.4 for Electrical Engineering and similarly structured Evaluation Schedules/Appendices and items 2.2, 2.3 and 2.4 for Civil Engineering and similarly structured Evaluation Schedules/Appendices.

3. Extension of closing date

Transnet received the request below from some bidders.

"Extension of deadline to the end of January 2023: The amount of work required to put a competitive offer for a submission of this kinds – 13 disciplines with unique bid requirements. Festive holidays with majority of the people taking leave (Office closures from mid-December to 2nd week of January). Sourcing and partnering arrangements for non-core disciplines."

In response to the above request, Transnet decided to change the closing date for the submission of the tender document from **14 December 2022 at 16h00** to the new closing date of **27 January 2023 at 16h00**.

Kindly also note that the closing date for clarification questions will be at **16h00** on **20 January 2023.**

All other terms and conditions of the bid documents remain unchanged.
