The Inkosi Langalibalele Municipality subscribes to the Preferential Procurement Regulations, pertaining to the preferential procurement policy framework act (PPPFA) principles. The tender will be evaluated on either 80/20 or 90/10 as per the PPPFA Regulations 2022 and shall be based on pre-qualification and functionality. Bidders are required to submit a Company Profile accompanied by the Proof of registration with the Unemployed Insurance Fund (UIF) from department of Labour, Proof of registration with the Employees Provident Fund, Registration and proof thereof with ICASA (Independent Communication Authority South Africa) for radio equipment and frequencies used or fully

explained communication plan, Valid Letter of good standing with Compensation Commissioner (COIDA) from department of Labour, Valid Proof of Registration with PSIRA for the company and recent contribution payment thereof, Valid Letter of good standing with Private Security Industry Regulation Authority (PSIRA), Proof of registration with PSIRA for Directors/Shareholder/ Members, Copies of different valid Firearm Licenses in the name of the Company, Statement of Municipal Rates not older than 3 months, Public Liability Insurance, Audited Financial Statements for the previous three years. company's CSD (Central Supplier Database) Report, CIPC Documents, Certified Identity Documents of all Directors, Valid Tax Clearance Certificate/PIN from the Receiver of Revenue, Rates and Taxes Statement **obtainable from the Local Municipality**, alternatively, Valid Lease Agreement. Please note that the onus is upon the tenderer to ensure that the Tax matters are **always** up to date.
