BUSINESS UNIT RESPONSIBLE FOR THE BID

Occupational Health and Safety is a division under COO that is responsible to ensure the compliance with the requirements of the Occupational Health and Safety Act 85 of 1993 as amended and international safety management standards.

For effective and efficient functionality to assist with the continual implementation and maintenance of the OHS functions within SANParks. Compliance to Health and Safety is a legal requirement, hence sustainability is of importance.

Medical surveillance is required by law to be carried out in workplaces where employees are exposed to hazards. The hazards that require medical surveillance include noise, asbestos, certain chemicals, certain biological agents, lead but not limited to the mentioned stressors. It is the responsibility of the employer to ensure that the medical surveillance is carried out and the employer must pay for the service of a medical professionals

CONTEXT OF THIS PROCUREMENT

SANParks intends to appoint a panel of Occupational Health Service provider to comply with the national legislation and ensure that its employees adhere to the best occupational practices and international standards. Therefore, the organization has to ensure that they source a reputable partner to assist with provision of the occupational medical services that will promote the health and safety of its employees.

The service provider(s) should have an established networks of allied medical professionals to ensure that employees have reasonable access to emergency care especially in the remote parks. This means that the service provider(s) must be as and when required available (on call) 24 /7 Hours for emergency.

Furthermore, the service provider(s) should ensure that all SANParks occupational health activities are managed in an integrated manner and are fully functional, including establishing and maintaining an appropriate referral system for the individual, group or organization to variety of disciplines in medicine.

The duration of this contract will be for a period of 3 years.

- (b) All written transcripts of confidential information disclosed verbally by the SANParks; and
- (c) All material embodiments of the contract intellectual property.

The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.
