I have a question wrt the BOQ of the attached, please advise if you can assist and clarify if my applied logic is correct as per the below. Does this mean the daily requirement is 22 breakfast & 18 lunch meals a day (rounded up) for normal time?

The figure of 36 represents the contract period in months (36 months = 3 years). The monthly requirement is 17,000 meals. When spread over 22 working days per month, this equates to approximately **772.73 meals per day (rounded to 773 meals/day)**.
