## **1. INTRODUCTION**

Onsite reuse of treated greywater/blackwater/wastewater is becoming an important water efficiency and water security opportunity for domestic households (planned and unplanned), buildings and apartments, estates, informal settlements, commercial and industrial developments in South Africa. Dealing with challenges of water scarcity, exacerbated by climate consequences, onsite reuse becomes an important part of the reducing vulnerability and increasing resilience by using a water mix approach for continuity of supply and service.

The South African national government has recognized this potential and have established compulsory norms and standards enabling onsite reuse under the term Water Efficient Sanitation Solutions (WESS). As per 2025 DWS revised compulsory norms and standard, WESS are sanitation systems which require low to no water, completely off-grid, non-sewered, onsite or are decentralised and utilizes technologies that includes using water saving devices, water efficient processes and beneficial use of products.

The Water Partnerships Office (WPO) is a strategic initiative jointly developed by the Department of Water and Sanitation (DWS), the Development Bank of Southern Africa (DBSA), and the South African Local Government Association (SALGA) under the auspices of the National Water Partnerships Programme (NWPP). While the NWPP is owned by the DWS, the Water Partnerships Office (WPO) has been established as a ring-fenced entity within the DBSA to operationalise and facilitate the implementation of the programme. The WPO's mandate includes creating a municipal enabled and private sector driven sanitation service delivery model by supporting design, financing and new management practices which are standardized and ready for uptake by municipalities.

## **2. PURPOSE AND OBJECTIVE OF THE RFI**

In line with its mandate, the WPO is setting up a database of solutions and products for the development of a comprehensive, national database of onsite greywater / blackwater / decentralised wastewater treatment technologies which may include reuse of treated effluent, sludge and/or energy. The call is also designed to understand what short- and long-term service offerings companies in or outside of South Africa offer. The RFI seeks to identify technology developers, solution providers, and service providers whose technologies and service models (if applicable) have been tested, demonstrated, piloted, or implemented across various market segments (such as informal settlements, schools, housing estates, eco-estates, commercial nodes, affordable housing, high density housing, social housing, green buildings) in the country.

The resulting database will serve as a credible, up-to-date reference for national and local government, public entities, financiers, developers, and private-sector partners to support informed decision-making, project preparation, procurement and scaling of sustainable solutions. The scope of this RFI is to identify a broad range of onsite greywater / blackwater / decentralised wastewater treatment technologies in the market that can support South Africa's response to increasing urbanisation, water scarcity and service delivery backlogs. It aims to:

- 1.1 Identify suitable onsite blackwater, wastewater and greywater technologies, services and system configurations
- 1.2 Understand technical capabilities of the sector, system scalability options to be considered, technology performance and treatment outcomes
- 1.3 Obtain indicative cost structures (CAPEX, OPEX, lifecycle costs)
- 1.4 Understand performance, regulatory outputs
- 1.5 Identify potential service (implementation, operation and maintenance) models
- 1.6 Assess local content, skills transfer and job creation opportunities
- 1.7 Assess socio-economic benefits your technology and systems may provide.

Respondents must ensure that their RFI Responses are as comprehensive as possible and include the information requested in each of the Response Forms that are applicable to them. Respondents are allowed to submit more than one Response if they have more than one onsite greywater / blackwater / decentralised wastewater treatment technologies.

Please note that the DBSA does not intend to use the RFI or the RFI Responses as a "pre-qualification" for Respondents to be invited to participate in any potential funding procurement process that may be launched in the future nor any potential programme undertaken by the DBSA. However, Respondents are urged to respond to this RFI to ensure the successful establishment of an extensive Database of onsite greywater / blackwater / wastewater treatment technologies.

Submissions should be made electronically by no later than close of business 23:59 pm (CST) on 19 June 2026. Submission time will be interpreted as, the time when electronic submission reached the DBSA's electronic mailbox and not when the submission left the sender's electronic mailbox. The DBSA reserves the right not to accept submissions after this time.
