- Tenderer must be able to prove that they will be able to provide the plant and equipment if selected, by providing the logbooks or the lease agreement.

- The municipality will accept no responsibility for the late delivery of bids by courier services or any other forms of mailing.
- Tenders shall remain valid for 90 days from the closing date (**17 April 2023**)
- All attached copies of certificates must be certified
- The council reserves the right not to appoint.

THE ABOVE BIDS WILL BE EVALUATED ACCORDING TO THE FOLLOWING CRITERIA:

Nkandla Local Municipality subscribes to the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000) read with The Revised Preferential Procurement Regulations – Gazette No. 27636, 30 May 2005. Tenders will be evaluated in terms of their responsiveness to the tender specifications, requirements, and functionality.

- **First Stage:** Compliance.
- **Second Stage:** Functionality, 100 points (Minimum threshold of 70 points) being 40 points for Experience, 30 points for Key personnel, 20 points for Plant & Equipment & 10 points for Locality.
