The course content should achieve the following minimum outcomes:

1. Use SASL vocabulary with correct finger spelling and basic sign language structure.
2. Interact in SASL in a simple way, using simple phrases to describe, discuss and ask about everyday topics, as well as topics associated with areas of immediate need (including greetings, talking about the family, occupations, daily routines and social arrangements).
3. Ask and answer questions.
4. Engage in short conversations with a Deaf person and groups on a familiar topic using South African Sign Language
5. Demonstrate the production and reception of one hand finger-spelling alphabet
6. Describe familiar people, places and events, holiday destinations and the weather.
7. Ask about and give personal descriptions of oneself and others, express likes and dislikes, and ask for and give directions
8. Request information and permission.
9. Conduct short personal interactions.
10. Deliver a monologue of not less than three minutes on familiar topics, such as personal information, social information, and/or general information about people and things within the person's own experience, or specific situations or topics that have been well rehearsed.
11. Deliver a monologue to a known audience on a familiar topic using SASL
12. Perform everyday communicative tasks using SASL

1.6 The organ of state reserves the right to require of a tenderer, either before a



tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **"tender"** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **"price"** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **"rand value"** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **"tender for income-generating contracts"** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/documentation stated in the conditions of this tender:

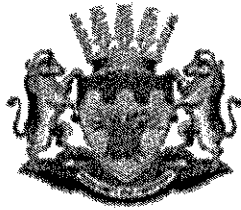
