Pricing Instructions:

1. All prices shall be tendered including VAT, customs or excise duty and any other duty, levy, or other applicable tax.
2. All prices shall be tendered in accordance with the units specified in this schedule.
3. All prices tendered must include all expenses, disbursements and costs (e.g. transport, overheads, accommodation etc.) that may be required in and for the execution of the work described in the Specification, and shall cover the cost of all general risks, liabilities and obligations set forth or implied in the Contract as well as overhead charges and profit (in the event that the tender is successful). All prices tendered will be final and binding.

1. PURPOSE

The infrastructure department is responsible for the provision of basic services. In order to effectively ensure this, it should have a functional plant unit to carry out its mandate of the department. The department has devised a turnaround strategy of making use of external service providers who will provide us with new tyres and repair of old plant tyres for the purpose of making more production for importing the road material on our road maintenance at a normal rate.

2. BACKGROUND

The Ingquza Hill Local Municipality wishes to invite potential service providers to provide the new plant tyres and also to repair damaged old tyres. This will assist our municipal plant to render services efficiently with machines able to move. Ingquza Hill Local Municipality is a category B municipality with municipal offices in Flagstaff and Lusikisiki. We therefore require prospective service providers to quote on the provision of the new and repair of old tyres for our plant.

3. SCOPE OF THE PROJECT

- 3.1 The successful bidder will be expected to provide the municipality with plant tyres for the Ingquza Hill Local Municipality within a month after appointment.

4. Standards

4.1 The service provider shall confirm with the standards mentioned in the bidding documents and specifications.

5. Incidental Services

- 5.1 The service provider may be required to supply the institution with Tyres for the plant that will be working within the area of Ingquza Hill Local municipality.
- 5.2. Prices charged by the service provider for incidental services, if not included in the contract price for the services, shall be agreed upon in advance by both the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

6. Payment

- 6.1 The method and conditions of payment to be made to the supplier under this contract shall be specified.
- 6.2 The supplier shall furnish the purchaser with an invoice on a monthly basis and upon fulfilment of other obligations stipulated in the contract.
- 6.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.

7. Prices

7.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his/her bid, with the exception of any price adjustments authorized or in the purchaser's request for bid validity extension, as the case may be.

8. Variation orders

8.1 In cases where the estimated value of the envisaged changes in purchase does not vary more than 15% of the total value of the original contract, the service provider may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the service provider may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

9. Settlement of Disputes

9.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

9.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.

9.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.

9.4 Notwithstanding any reference to mediation and/or court proceedings herein,

(a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and

(b) The purchaser shall pay the supplier any monies due the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

10. Termination for insolvency

10.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the purchaser.

11. Applicable law

11.1. The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

12. Transfer of contracts

12.1. The contractor shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser.
