- Bidder to refurbish the entire firefighting trailer.

Trailer refurbishment

- The entire trailer must be stripped down completely to the subframe.
- The entire unit must be sandblasted.
- The entire unit must be rustproof and primed.
- The entire unit must be repainted with 2 K Red paint at least three coats.
- Both rims must be sandblasted, primed, and repainted with 2 K white paint.

MECHANICAL WORK TO BE DONE.

- The Honda engine must receive a major service.
- Air filter to be replaced.
- Oil to be drained and replaced.
- New sparkplug must be fitted.
- In-line fuel filter must be fitted between the fuel tank and the carburettor.
- All water valves must be serviced for ease of opening and closing.
