- 1.6. The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/documentation stated in the conditions of this tender;

1. BACKGROUND IZIKO

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

2. DESCRIPTION

The Iziko Museums of South Africa hereby invites suitably qualified and experienced service providers to submit official quotations for the provision of professional museum collection handling, transportation, packing, storage and reinstatement services relating to the household contents (artefacts) of the Nelson Mandela Prison House Museum, Paarl

3. SPECIFICATION

The Nelson Mandela Prison House Museum, Household Collection is currently stored offsite following its removal from the Nelson Mandela Prison House Museum, Paarl. The collection is presently wrapped, packed and secured in boxes at the current service provider's storage facility.

4. Scope of Works

The appointed service provider will be required to provide the following services:

a. **Removal of Museum Collection**

Removal of the museum household furniture collection from the current storage facility of Pack-Art CC, Unit 1, 19 Senna Road, Killarney Gardens, Milnerton. *See Annexure 1* attached.

b. Transportation of Collection

Professional transportation of the museum household furniture collection from the current storage facility to the newly appointed service provider's storage facility.

c. Storage Services

Provision of secure storage facilities for a period of six (06) months, payable monthly.

(Please note: The storage period may be extended depending on the progress and completion timeline of the restoration works at the Nelson Mandela Prison House Museum site.).

d. Packing Services

Provision of any additional protective packing and handling required prior to transportation and delivery of the collection.

e. Return Transportation

Provision for the transportation of the museum household collection from the storage facility back to the Nelson Mandela Prison House Museum, Paarl, upon completion of the storage period of duration of 5 Months.

f. Unpacking and Reinstatement

Provision of labour and professional services for the unpacking, placement and reinstatement of all household contents (artefacts) to their original and/or designated locations within the museum.

g. Insurance Cover

The quotation must include comprehensive insurance cover to the value of R100 000 content cover for the duration of the contract.
