Patrol duties shall entail patrolling the ASEZCo sites regularly day and night.


The service provider shall provide a patrol monitoring equipment (Bloodhound) which shall be used as a patrol tool for the security officers.



INTRODUCTION TO ATLANTIS SPECIAL ECONOMIC ZONE (ASEZCO)

Atlantis lies about 40km north of Cape Town. Travelling north along the West Coast Road (R27), the Atlantis Industrial area is 43km from the Port of Cape Town and 18km from Melkbosstrand. It lies south of Dassenberg, and 108km south of the Port of Saldanha.

Special Economic Zones (SEZ's) are key tools used by the South African government for driving industrial and economic development. Within SEZ's, cluster industries from a particular sector locate in geographically designated areas to get the benefits of scale and co-location. SEZs are governed by the SEZ Act (No.16 of 2014) and are supported by a range of incentives aimed at attracting foreign and local investment.

The City of Cape Town established a greentech manufacturing hub in Atlantis in 2011, in response to the Department of Energy's Renewable Energy Independent Power Producer Programme (REIPPP).

The hub has already attracted six greentech investors that are operational and another who will be operational by March 2024. The six investments were made on 25 hectares of privately owned land which forms part of the designated Atlantis SEZ, whilst the seven is on ASEZCo owned land in Zone 1 of the ASEZ.

In 2015, the Western Cape Provincial Government applied for the designation of the Atlantis Special Economic Zone (ASEZCo) for green technologies. After thorough engagement and assessment, the South African Cabinet in June 2018 approved the decision by Minister Rob Davies to designate the Atlantis SEZ

as South Africa's greentech SEZ.

Situated on the West Coast of South Africa, 40 km from Cape Town, the ASEZCo capitalises on the province's already booming renewable energy and green technology sector.

Greentech refers to green technologies that reduce or reverse the impact of people on the planet. These include renewable energy technologies. Wind turbines, solar panels, insulation, biofuels, electric vehicles, materials recycling and green building materials are all examples of green technology.

The following elements make the Atlantis SEZ a competitive investment destination:

- 1. A strong and growing South African and African market for greentech manufacturing. Independent market research shows strong demand for renewable energy and green technologies from South Africa and the African continent.
- 2. Well-located & development-ready area. Large tracts of industrially zoned land with appropriate bulk infrastructure in place (green and brown fields).
- 3. Provision of green star rated industrial facilities and infrastructure, contributing to the sustainability of the industrial activity locate din the ASEZ.
- 4. New public transport links and fibre connectivity. The site is well located and in close proximity to Saldanha port (105 km), airports, and Cape Town (40kms). The SEZ offers good access to major national road network (N1, N2 and N7 routes).
- 5. Proximity to key renewable energy markets. There is a strong support base and existing relationships for investors to tap into; including partnerships and relationships that will help facilitate investment and doing business are already in place with business, government and labour.
- 6. Incentives for investors and tenants. The ASEZCo (through the National Government) and the City of Cape Town (CoCT) offer a range of attractive incentives for investors and tenants.
- 7. An attractive, wide-ranging skills base that can be recruited from the City of Cape Town and the Western Cape Province. The Cape Town and Western Cape area offer a large range of unskilled, semiskilled, technical and professional candidates. A skills development drive is underway in Atlantis through partnerships with youth organizations, local colleges and high schools.

THE BIDDER PROCUREMENT SELECTION PROCEDURE

Stage 1 – Verification of the ability and capacity of a bidder to provide the services in accordance with contract as set out in the bid documents.

Responsive to submission requirements

Bid that meets all the submission requirements in the bid document is a responsive bid that proceeds to the next stage. The ASEZCo's evaluation committee will disqualify non-responsive submissions.

Meeting technical specifications

The evaluation committee will disqualify responsive submissions that do not meet the minimum technical specifications and thresholds set out in this document.

Stage 2 – Pricing Evaluation

The evaluation committee will compare each bidder's pricing quote on a fair comparison basis considering all aspects of the bid's pricing requirements. The evaluation committee will rank qualifying bids on points scored relative to both Price and B-BBEE rating in accordance with the PPPFA and as indicated on SBD 6.1.

Stage 3 - Award and Contract Signing

The bid contract will be awarded (post approval by the ASEZCo's Delegated Authority) to the bidder with the highest combined score for Price and BBBEE rating unless there are other objective criteria, specified upfront in the bid documents that need to be considered in addition to the combined score. The award is subject to the final verification of the bidder's tax status as set out in the SBD 1 through the CSD.

Cancellation of the bid prior to award

The ASEZCo reserves the right to cancel this bid invitation prior to making an award where:

- a) Due to changed circumstances there is no longer a need for this procurement, or
- b) No bids meet the required specifications, or a material irregularity occurred in the bid process, or
- c) Where the price is too low/high in comparison to the market price range determined by the ASEZCO or the budget allocated by the ASEZCo to this procurement.

SPECIFICATION OF BIDDER COMPETENCIES FOR EVALUATION

DETAILED SPECIFICATION

1. SCOPE OF SCURITY SERVICE

The ASEZCo seeks to appoint a security service provider to provide 24 hour / 7 days a week physical security services at its land in Atlantis in the form of patrolling.

- 1.1. Bidders are required to provide health care fund deduction and Premium allowance contributions.
- 1.2. The awarded bidder may be requested to appoint at least 50% local security personnel.
- 1.3. First aid and basic fire fighter certificates for security personnel will be required.
- 1.4. The appointed company must be able to supply a tactical response team on as when required basis.

2. GENERAL DUTIES

- 2.1 To perform access control duties (where applicable) and patrol the land to prevent persons from illegally entering.
- 2.2 To guard and protect the ASEZCo equipment and material against damage, theft and vandalism.
- 2.3 To apprehend any suspicious person on the land and take action as mandated to.
- 2.4 To report any suspicious action or unusual occurrence to an official of the employer as instructed to.
- 2.5 Guards must be supervised on the daily basis by their superiors and equipped to perform their duties as agreed upon from time to time. Supervisors are required to represent themselves to the ASEZCo for discussion at least once a week.
- 2.6 Security guards must be dressed in a distinctive uniform of the contractor rendering the service.

 Uniforms and equipment must be worn all time for the duration of the shift and equipment allocated to the guards must remain under his\her control.
- 2.7 To patrol the area of responsibility, to prevent the vandalism and theft of ASEZCo's assets.
- 2.8 To prevent people from illegal dumping, erection of structure on and occupying premises under contractor's control and the ASEZCo.
- 2.9 To monitor security threats and risk within the ASEZCo's zones of responsibility and provide an early warning system to facilitate proactive invention.
- 2.10 The contractor shall report to the ASEZCo representative overseeing the contract, all incidents within twelve (12) hours of occurrence/discovery.

3. DAMAGE

3.1 Any damage caused by the contractor or his staff to a private or ASEZCo's property and existing

services must be repaired at the contractor's expense.

3.2 Any property found by others which could implicate the contractor in any way must be reported to security management before any work commences.

4. COMPLIANCE

4.1 In terms of this contract all security service contractor/s and their employees utilized on the premises of the employer, shall at all times during the term of this agreement, be registered in terms of the PSIRA (Private Security Industry Regulation Act, Act 56 of 2001 and comply with the Private Security Industry Regulation. Certified copies of the relevant certificates shall be forwarded to the employer on submission of this tender. The service shall confirm to the standards mentioned in the binding and specification.

5. MANAGEMENT AND SUPERVISORS

- 5.1 The employer may delegate to any other person, any of his powers or functions in terms of this agreement and on receiving notice in writing of such delegation, the contractor shall recognize and obey the delegated person to whom any such powers or functions have been delegated as he/she was the employer.
- 5.2 The contractor shall always exercise supervision over the service at each premises or shall be competent and responsibility and shall have adequate experience in carrying out work of similar nature to the security service provided in terms of this contract/agreement and shall exercise personal supervision on behalf of the contractor.
- 5.3 Personnel provided by the contractor may on occasion render certain services under the control and supervision on behalf of the employer.
- 5.4 The employer shall always during the term of the contract, monitor the contractor's services, or cause them to be monitored without prior notice.
- 5.5 The contractor shall be required to carry out proper supervision of his own personnel by means of at least two visits by an offsite supervisor of manager during the hours of duty. Details of such visits shall be in the occurrence book provided by the contractor and the pocketbooks of the security personnel visited.
- 5.6 In the event of a strike action by the employees of the security company, the company must provide backup services to ensure that all ASEZCo's property is always protected. Any claim that might arise due to the non-coverage of the specific point will be on the account of the security company. The company should make provision for such claims that may arise in case of a strike action and must be included in the bidding price.
- 5.7 In the event where ASEZCo's property, assets were compromised and it was proven negligent on contractor's part, the company will bear the cost associated with remedying the situation.
- 5.8 The ASEZCo reserves the right to increase or decrease the personnel, quantity of guards required at any time during the period of the contract.
- 5.9 All guards should not have a criminal record.
- 5.10 The company must be registered with PSIRA.

- 5.11 The company must comply with all relevant legislation which regulates the private security industry such as the Act on Private Security, the Firearms Control Act etc.
- 5.12 The company must have its own or rented radio operator/s, which is licenced with the independent Communications Authority of South Africa (ICASA).
- 5.13 The company must be able to provide additional Guards and Vehicles when needed, within 12 hours of such request.
- 5.14 The monitoring of security guards must be done electronically, and reports must be submitted monthly.

6. TENDER SECURITY MANPOWER REQUIREMENTS

- 6.1 The schedule of the tender will be attached which shows the following:
 - a. The security grades e.g. A to C
 - b. The site/places to be guarded
 - c. The hours of duration of shift e.g., Day or night and 24/7
 - d. Minimum branded Two Vans (LDVs) with spotlights
 - e. Tactical Response Team must be available as and when required.

7. OUT OF SCOPE INFRASTRUCTURE SERVICES

Not all aspects of ASEZCo's security services are within the scope of this Request for Proposal. The following are considered out of scope:

- 5.1. Physical guarding at after hours events i.e Information Sessions, Council Events, Marketing events
- 5.2. Escorting ASEZCo staff home after events
- 5.3. Drone footage may be required from a pilot using a drone for commercial operations which must be a pilot to be registered and operate under Part 101 of the SACAA regulations.

18.1	No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
GCC19	Assignment
19.1	The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
