A question Mr Mfalapitsa, what if you only have GPS Equipment, how will you be scored on criteria requiring the calibration certificates?

### Answer

**Please provide the calibration certificates for equipment that have calibration certificates. For GPS just send the specifications it will not be scored because it does not require calibration certificate it is calibrated on site.**

Also - "Plan and drill groundwater-monitoring boreholes representative of the site (min 3) distributed across the site." - This is normally outside our survey scope?

**Answer**

**The task that you are mentioning have been requested by our end users also this contract allows for 25% of work to be sub-contracted. It will depend on the requirements from the end user. We are not scoring you on the tasks that you can not provide as a company.**

**We are looking for a panel of service providers not a single service provider**

Concerning the Eskom courses required. Some of the courses are unavailable currently and will come after the tender has closed. Can we provide certificates after the awarding of the tender? Pity some of our certificate has expired. Can you help with courses which are in pipelines?

**Answer**

**Please provide the certificates that you have expired or an attendance register or any proof of attendance. It will be renewed after the tender is awarded.**

Could you possibly consider extending the deadline for the submission of this tender?

**Answer**

**It is not possible because there are requests from the end users/Eskom departments that have to be fulfilled by this contract. For some projects e.g the new build of Infrastructure like Medupi/ Kusile power stations we need monitoring as construction is carried out and we are already late on providing the services. The survey resources we have can not cope with the amount of work required.**

Is subcontracting allowed?

**Answer: yes 25% of the scope only is allowed to be subcontracted.**

Under the technical evaluation, provision of testimonial will it be acceptable if we provide purchase orders instead of requesting letters from Eskom?

**Answer : Purchase order Yes they are welcome.**

We have assisted smaller company in the previously contract and subcontracted them to carry out some of the stockpile surveys on our behalf. The small company is now intending to tender for MWP1069DX and requested a testimonial letter from us.

Seeing that we are also tendering for the same, giving them testimonial will not be viewed as double dipping?

**Answer: yes they can Tender as well, Yes you can provide them the testimonial letter.**
