1. PURPOSE

The Kwazulu-Natal Growth Fund Trust (KGFT) invites proposals from suitably qualified service providers to provide KGFT with a research study.

2. BACKGROUND

KZN Growth Fund Trust (KGFT) is a Trust, established and capitalised by the Provincial Government to provide debt and equity. The main objective of the KGFT is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

2.1 Procurement Philosophy

It is the policy of KGFT, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy,
- b) The promotion of national and regional local service providers and agents before considering overseas service providers, and
- c) The development, promotion and support for the moral values that underpin the above, in terms of KGFT Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KGFT.

The KGFT wishes to engage with service providers who are equally committed to maintain high quality services and better pricing.

3. INTRODUCTION AND RATIONALE

The research study is required to enable a high level assessment of socio-economic impact of gambling and liquor industries, to enable the KGFT to understand the likely socio-economic impact of the gambling and liquor industry on the economy and its population, which will inform its ESG and Investment policies.

The study should therefore also provide a brief overview of interest/lack thereof in funding the gambling and liquor industries as well as the sector performance and contribution to economic activity.

4. OBJECTIVES

The primary objectives of the socio-economic impact analysis are as follows:

- 4.1 Briefly assess the economic impact of the gambling and liquor industries on the provincial and national economy.
- 4.2 Examine the social consequences and benefits associated with the presence and operation of these industries.
- 4.3 Evaluate the regulatory environment and its effectiveness.
- 4.4 Provide recommendations for potential investments to gambling and liquor industries and policy decisions for Developmental Funding Institutions (DFIs).
- 4.5 To assess the difference in levels of gambling between different population groups and the geographical coverage of various gambling modes.
- 4.6 To assess the potential growth of various gambling modes in view of its value chains.
- 4.7 To assess the consequences of gambling on employment losses and gains.
- 4.8 To assess the consequences of gambling on the social welfare of individuals and communities.
- 4.9 To understand the propensity of gambling in the province.

5. SCOPE OF WORK

The service provider shall:

- 5.1 Conduct a high-level review of the gambling and liquor industries, including their history, status, and trends.
- 5.2 Assess the direct and indirect economic contributions of these industries, such as employment, revenue generation, and taxation.
- 5.3 Analyse the social impact, including effects on public health, addiction rates, and the community's well-being.
- 5.4 Conduct a comparative analysis with other provinces, and international to determine patterns and trends.
- 5.5 Provide a write-up on environmental impact of the gambling and liquor industry.

- 5.6 Evaluate the regulatory framework governing these industries, including its strengths and weaknesses.
- 5.7 Report on how other Developmental Funding Institutions (DFIs) in South Africa (and internationally) are funding the industry and what is excluded and rationale for those exclusions.
- 5.8 Advise if there is any legal and policy framework from the government that informs such exclusions.
- 5.9 Provide recommendations for KGFT regarding potential funding or policy changes.

6. METHODOLOGY

- 6.1 Describe the research methods, data sources, and data collection techniques to be used.
- 6.2 Specify the criteria for selecting sample populations and regions to be studied.
- 6.3 Explain the analysis techniques, including economic modelling, surveys, interviews, and data analysis tools.

7. DATA COLLECTION

- 7.1 Detail the data sources to be used, which may include government records, industry reports, surveys, and interviews with stakeholders.
- 7.2 Provide a timeline for data collection, ensuring it aligns with the project schedule.



1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
