Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort precinct. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC owns and manages a property portfolio comprising of commercial and industrial buildings/facilities located within the Dube TradePort precinct. DTPC would like to procure the services of a competent service provider to provide a turnkey solution in the safe removal, supply, protective coating and replacement of chiller condenser coils and compressor at the Dube TradePort Corporation AgriZone 1 in the first year; and supply major HVAC parts in the second and third year of this contract.

It is estimated that tenderers must have an active CIDB contractor grading designation of **3ME** by the closing date of the bid. Bids from bidders registered as potentially emerging enterprises (i.e., with a PE status) but with a **CIDB contractor grading designation lower than 3ME will not be allowed to tender.**

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points will be allocated to the following as included in the bid document:

I. Enterprises (or bidders) who are at least 51% or more owned by Black People
