In order to rectify the under clearance, on the Kusile – Zeus 400 kV line between towers 39 and 40, it is recommended to install a new 518H tower of CAH of 26m, 30m away from existing tower 39 towards 40.

The existing tower 39 should be removed. This addition of a new higher suspension tower will pick up the conductor to above 12m clearance over the road at full load.

The table below lists the basic scope of work developed by LES but will be discussed with the appointed contractor for acceptance and changes that will be required by them to execute the work safely.

It is noted that the foundations for the tower have been completed. The scope of work will therefore focus on the work above ground level, tower assembling, erection and dressing as well as conductor stringing and regulating. LES recommends that the installed foundations be checked, to ensure that all specifications are met according to the accepted design drawings and TRMSCAA 6.0.
