



**TENDER NOTICE AND INVITATION TO TENDER  
TENDER NUMBER: CI-GK-0132**

South African National Parks invites tenders for the **Design, Construction, Delivery, Commissioning and Maintenance of Solar PV Plants at Mata Mata and Nossob camps in the Kgalagadi Transfrontier Park in the Northern Cape Province.**

The following functionality criteria applies for the tender:

Experience in relation to the number and value of recent projects hybrid/ photovoltaic installation/ construction (on-grid and off-grid):
Experience in relation to the size and technical specifications of recent projects
Qualifications and experience of key personnel accountable/ responsible for this project
Methodology and approach to the project

Details of the functionality criteria and evaluation points are included in the tender document.

It is estimated that tenderers must have a CIDB grading designation of **6EP or Higher**. Tenderers who satisfy criteria stated in the tender data may submit tender offers.

Only tenderers who comply with the following are eligible to submit tenders:

- Have the required and valid CIDB grading stated
- Achieved the minimum score for Functionality (minimum of 70%)
- Tenderer is not listed in the Register of Tender Defaulters and prohibited from doing business with the public sector.
- The tenderer has not abused the Employer's supply chain management system
- The tenderer has not failed to perform on any previous contract with the employer.

**Tender documents will ONLY be available at the compulsory clarification meeting.**

A non-refundable tender deposit of R 300-00 payable in cash is required on collection of the tender documents.

A compulsory clarification meeting with representatives of the Employer will take place at the **Twee Rivieren Rest Camp, Management Boardroom, Kgalagadi Transfrontier Park, Northern Cape**

**Province on 24 November 2022 starting at 11:00 hrs.** The Tenderer shall inspect and examine the site and its surroundings and shall satisfy himself before submitting his tender as to the form and nature of the Site, the quantities and nature of the work and materials necessary for the completion of the Works and the means of access of the Site, the accommodation he may require and in general shall himself obtain all necessary information as to risk, contingencies and other circumstances which may influence or affect his tender. The tenderer must be represented at the site inspection by a person who is suitably qualified and experienced to comprehend the implications of the work involved. Tenderers with due consideration of the distance and speed limit in the park can arrangement to visit the two sites in Nossob and Mata Mata. Attendance of the site inspection is compulsory and a tender will be disqualified if the site inspection is not attended by a representative of the tenderer.

***NB: Please note that the nearest town and airport is Upington and is approximately 260km from Upington to Kgalagadi Transfrontier Park.***

**The closing time for receipt of tenders is 09 December 2022 @ 11:00 hrs.** Telephonic, telex facsimile, e-mail and late tenders will not be accepted.

Tenders may only be submitted on the tender documentation that is issued.

Requirements for sealing, addressing, delivery, opening and assessment of tenders are stated in the Tender Data

As part of the eligibility criteria, tenderers shall further be required to satisfy the functionality criteria set in the tender document.

Tenders are required to demonstrate their ability to undertake the works considered to be complex and to provide proof of experience, expertise, qualifications, personnel, plant and equipment to undertake work of this nature.

Tenderers are required to score a minimum of 70 points to be responsive: Tender Data, of the proposed functionality criteria and point system for evaluation is included in the tender document.

Tenders in sealed envelopes marked clearly with the identification details: **“Tender No CI-GK-0132-: Design, Construction, Delivery, Commissioning and Maintenance of Solar PV Plants at Mata Mata and Nossob camps in the Kgalagadi Transfrontier Park in the Northern Cape Province,** must be deposited in the tender box at the Main Entrance Gate, SANParks Head Office, Groenkloof, 643 Leyds Street, Muckleneuk, Pretoria, 0002 on or before the stated closing date and time.
