The fabricated steel stand for the water supply JOJO tank is exposed to the coastline therefore the steel material has corroded.

The steel stand has collapsed and the JOJO tank is now unsupported and requires a new stand to urgently be built to ensure the availability of water supply to the guardhouse building.

- Strip and remove the corroded existing steel stand;
- Construct 2m x 2m masonry JOJO tank stand of 1m height;
- Construct 2m x 2m reinforced concrete slab of 170mm thickness on top of masonry walls.
