EVALUATION CRITERIA

The bids will be evaluated on the basis on the Preferential Procurement Policy Framework Act (ActNo.5, 2000), and the regulations pertaining thereto (2017), as well as the Joe Gqabi District Municipality's Supply Chain Management Policy 80/20 preference point system will be used.

Bids will firstly be evaluated on functionality, and thereafter on a preferential procurement points system.

In terms of Regulation 5 (2) and 6 (2) of the revised Preferential Procurement Regulations 2017, preference points must be awarded to a bidder for attaining the B-BBEE status level of contributions. Submission of a valid B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act(CCA) is a requisite. Sworn affidavits from Exempted Micro Enterprise (EME) with an annual turnover of R10 million and less will be accepted. Bidders will not be disqualified for non-submission of a B-BBEE Verification Certificate but will be declared as non-compliant contributor. Trusts, consortiums or joint

ventures are advised to submit a consolidated B-BBEE scorecard. Originally, certified copies must not be older than 3 months.



BIDDERS SHALL TAKE NOTE OF THE FOLLOWING BID CONDITIONS:

1. **JGDM shall not do business with any person in the service of the state**
2. **Bidders must be registered on National Treasury's Central Supplier Database (CSD)**
3. The Joe Gqabi District Municipality Supply Chain Management Policy will apply
4. The Joe Gqabi District Municipality does not bind itself to accept the lowest bid or any other bid and reserves the right to accept the whole or part of the bid and to award to more than one bidder.
5. Bids which are late, incomplete, unsigned or submitted by facsimile or electronically, will not be accepted
6. All pages must be signed where necessary

TERMS OF REFERENCE

EXPRESSION OF INTEREST: PANNEL OF SERVICE PROVIDERS FOR THE SUPPLY, DELIVERY AND OFFLOADING OF POLY LIQUID COAGULANTS CHEMICALS FOR A PERIOD OF 3 YEARS: JGDM 2020/21 – 009

SCOPE OF WORK

1.Municipality's objectives

The Joe Gqabi District Municipality seeks a Panel of Service Providers for the Supply, Delivery and Offloading of Poly Liquid Chemicals on an "as and when required basis" for a period of three years, to ensure an uninterrupted supply of suitable site specific coagulants, to all the water treatment works within Joe Gqabi District Municipality's jurisdiction.

2.Description of supplies and services

Supply, delivery, and offloading of Coagulants to all the water treatment works within Joe Gqabi District Municipality's jurisdiction. The polymeric coagulants/flocculants shall be cationic in nature, potable water quality grade and capable of satisfactorily treating water to SANS241 and Joe Gqabi District's Water Standards which are available on request.

It must be clearly understood that the tendered prices must include the costs of all arrangements necessary for the actual delivery of the good to the treatment works, the safe delivery and handling thereof, that is purity that meets the needs of the consumers and that it complies with all legislated requirements, SANS241, General Authorisation, and the Blue and Green Drop of the Department of Water and Sanitation. Annual training for safety audits, treatment plant optimization and hazmat response is also required for the duration of the contract. Periodic site visits must be included in the bid price.

The cost effectiveness of the supply of the polymeric coagulants for the treatment works is emphasized to ensure that portable water is produced as cost effective as possible.

Pricing will only be requested from those that meet the minimum functionality as outlined in the tender. This will be in stage 2 of the bid process.

Aliwal North Water Treatment Works has a river abstraction with rapid seasonal changes in Turbidities. Bidders will be testing on low and high turbidity. Bidders who have attended the briefing session will be called for testing on low turbidity when the river is low. Evaluation will then be done on low turbidity and high turbidity for Aliwal North.

2.Strategic Stockholding Requirements

The successful supplier is required to hold stock of raw material, equivalent to a single month supply, based on average usage of product by the sites, at his premises and costs. Joe Gqabi District Municipality reserves the right to audit the stock holding of the raw material at the successful supplier's premises, at any time during the contractual period. Should this ever drop to a level below one month of stock, Joe Gqabi District Municipality is to be immediately notified.

3.Quality plans and control

The successful bidder(s) must furnish Joe Gqabi District Municipality with an acceptable quality control systems e.g. NSF/ANSI 60, ISO 9001, ISO 1400 etc. Suppliers must provide the following information with regard to the coagulant product:

- a) Quality control certificate for each batch delivered
- b) Composition of the polymer or polymer blends stating:

- i) Viscosity
- ii) %Total solids and volatile solids

- iii) pH
 - iv) Specific gravity
 - v) % Monomer
 - vi) % Aluminium as Al₂O₃ (for blended products)
- Suppliers must provide the following information with each delivery products:

- a) Quality control certificate for each batch delivered.
- b) Composition of each product delivered.
- c) Material Safety Data Sheet (MSDS)

4.Approval for use in Potable Water:

The use of the polymeric coagulant, will be considered only if documentation is produced stating, to the satisfaction of Joe Gqabi District Municipality, that the use of the chemical in potable water has the approval of the South African Department of Health or any recognised International body such as the NSF, ANSI, USEPA, EU, WHO etc.

5. Site Visits And Special Services

The services to be rendered must include shall visit the water treatment works in the presence of a senior official (Manager: Water Quality) at least quarterly and performing the following duties:

- a) Jar Tester to optimise the coagulant dosing at each appointed treatment plant
- b) Check the efficiency of the coagulant provided (used) and give advice in case it needs to be changed to obtain optimal results on the final water.
- c) Quarterly reporting on the findings during site visits to be compiled and sent to the Manager Water Quality at NO additional cost to the Municipality.

The purpose of the site visit is to review the supplier's performance in terms of the contract and to evaluate chemical usage (plant optimisation) and make recommendations.

In addition to normal supply back-up services, the supplier shall also provide a rapid response technical support service on demand to enable JGDM to deal with a broad spectrum of treatment difficulties when these occur.

6.Training.

It will be required of the successful supplier(s) to provide continuous training and training material of the staff onsite and issue certificates to that effect on the following:

- 6.1 Safe handling, storage and the use of chemicals
- 6.2 Jar Test Procedure

Training will be hosted onsite at venues identified by the Municipality. All required wall charts, training material, MSDS and Hazard chemical labels must be supplied by the successful bidder at no additional cost to the Municipality. All costs related to this training will be at NO additional cost to the Municipality.

7.Signage.

The supplier must provide applicable safety sign/notices at all delivery sites, including the erection of such, as well as other relevant safety data sheets within a month after the commencement of the contract.

Quantities.

The quantities to be delivered and the frequency of delivery of coagulants shall be recommended by the supplier but may not be binding. JGDM reserves the right to either increase or decrease the quantities actually ordered.

Site information

The tender is applicable to the following Water Treatment Systems:

Maclear: Mooi River - 0.7Mℓ/day –river abstraction, rapid, extreme turbidity changes.

Maclear: Aucamp - 2 Mℓ/day – dam abstraction, rapid, mild turbidity changes.

Ugie - 6 Mℓ/day – river abstraction, rapid, mild turbidity changes.

Barkly East - 3 Mℓ/day – river abstraction, rapid, extreme turbidity changes.

Rhodes - 0.1 Mℓ/day – river abstraction, rapid, mild turbidity changes.

Sterkspruit - 12 Mℓ/day – dam abstraction, fairly mild turbidity changes.

Lady Grey - 3 Mℓ/day – dam abstraction, fairly extreme turbidity changes.

Aliwal North – 14.7 Mℓ/day – river abstraction, rapid, extreme turbidity changes.

Jamestown- 0.5 Mℓ/day – dam abstraction, fairly mild turbidity changes.

Burgersdorp - 7 Mℓ/day – dam abstraction, rapid, extreme turbidity changes.

Mount Fletcher - 6 Mℓ/day - dam abstraction, fairly extreme turbidity changes.

Steynsburg - 2 Mℓ/day – tunnel abstraction, fairly mild turbidity changes.

Oviston -5.6 Mℓ/day – tunnel abstraction, fairly mild changes.

Jozana - 1 Mℓ/day – dam abstraction, fairly, mild turbidity changes.

Bidders are to visit and conduct Jar tests for all 14 sited as indicated above. Bidders are to tender for all 14 sites as indicated above. Failure to do so will results in disqualification

Failure to provide proof for the above mentioned returnable documents will result in disqualification.

ADDITIONAL INFORMATION

1. Trial tests shall be conducted according to the technical specifications (annexure B) included with this tender and presented with bid documents.

2. Annexure B must be completed and submitted per site when conducting Jar test.

3. Only results of tests carried out on site shall be considered during the evaluation of results.

4. The test results shall be taken as indicative, and if during the contract period the efficacy of any chemical is sub-optimal, the supplier shall carry out full-scale plant trials to determine the most efficacious chemical for the site and water type in question.

5. A full analysis of chemicals offered is to be presented with bid documents. Bidders are limited to submitting one sample (500g) per site of the proposed chemical(s). Bidders are requested to put the Supplier's name, tender number and product name on the samples. The samples must be addressed for the attention of:

6. The products supplied shall be in accordance with the specifications and formulas as detailed in the Supplier's bid, and also submit details of their product quality control systems.

SPECIAL BID CONDITIONS OF CONTRACT

1. This contract shall be reviewed on performance and any other identified aspects, annually.

2. Contract Performance will be measured as follows:

3. Safety Plan

3.1 A draft Safety Plan covering the Transport, Handling, Emergency Procedures, Security of Supply Contingency Measures, Safe Disposal of non-compliant product and other relevant information such as officials' names and contact numbers must be provided to the municipality for acceptance within two weeks after the award of the tender. Once accepted, copies of the Safety Plan must be supplied to each user site within the JGDM within a month after granting the approval.

4. Award of contract

4.1 JGDM reserves the right to procure its requirement elsewhere outside the contract should the items be urgently required and not immediately available or in emergency cases, or in the case where items required are not included in this contract.

4.2 JGDM reserves the right to not procure all the items in the schedule at once.

4.3 If JGDM finds that a product is not suitable for all plants, JGDM reserves the right to split the contract.

5. Defects, contaminated or sub specification products

5.1 In the event of contaminated or sub-specification product being delivered to treatment plants, the Bidder will bear the cost of removing the chemical from Council property and disposing of the contents, if it is not possible to reprocess

it. All consequential costs as a result of the off-loading of the contaminated product will also be for the Bidder's account.

5.2 In the event of contaminated or sub-specification product being delivered to treatment sites the Bidder will also bear the cost of flushing, cleaning, repairing and re-commissioning all pipelines, dosing pumps and equipment, flow and mass measuring systems and/or other valves and appurtenances.

5.3 Inspection and testing must be carried out on all raw materials at each site on each delivery and record same on the delivery note.

5.4 Quality records must be maintained for reference by any credible external body Standards for packaging, storage and handling of products to be maintained.

5.5 Product packaging is to be identifiable and traceable.

5.6 Controlling and disposing of non-conformed product to be defined.

5.7 Settling of disputes and claims arising from non-conforming products received and supplied to be defined .Letters of compliance and certificates of analysis to be submitted with products when requested or when necessary.

6. Safety notices

6.1 The Bidder is required to provide appropriate safety notices, describing the agreed safety procedures to be adopted at the off-loading points as well as HAZCHEM safety information.

7. Packaging

7.1 Any receptacles and/or vessels for containing chemicals supplied such a tankers, cylinders or drums:

- Shall be leak proof/undamaged;
- Any leaking/damaged containers shall be immediately removed and replaced after notification to the Supplier by JGDM;
- All costs incurred resulting from leaking containers, before being delivered and offloaded onsite, shall be for the Supplier's account.

8. Transportation of Bulk Chemicals and Deliveries:

8.1 The Service Provider must deliver within 48 hours to seven (7) days of appointment, depending on the urgency of the chemical.

8.2 The Service Provider must deliver the required chemicals within 48 hours in emergency cases.

8.3 Upon delivery, letters of compliance Material Safety Data Sheets (MSDS) and certificates of analysis to be submitted with products.

8.4 The chemicals will be delivered at the various plants as listed in section 9 under the scope of works heading.

8.5 The Service Provider is required to provide labour, and equipment for the offloading of the chemical at all times. No JGDM employee will assist in this regard.

8.6 The supplier's vehicle driver shall be a Certified Hazchem Driver. Certification to transport Hazchem goods and Chlorine Handling Certificate must be provided on appointment.

8.7 The supplier's vehicle used for the delivery of chemicals shall be adequately equipped to off-load chemicals at the various delivery points.

8.8 The supplier's vehicle shall be in sound operational condition to ensure no leakage of chemical, oils and other substances when delivering or transporting chemicals to site.

8.9 The supplier's vehicle is to be clearly marked and carry all necessary safety equipment to ensure that off-loading can be conducted in a manner that will not endanger the environment or personnel. Non-compliance with this requirement shall render the vehicle unfit to enter the premises. The supplier shall however remain responsible to ensure that product is delivered on due date.

8.10 In the event that a delivery is not made on due date for whatever reason, the supplier shall be rendered in breach of contract and any remedial work arising from such a situation shall be for the supplier's account.

8.11 All containers shall be sealed and opened only at delivery point in the presence of an official.

8.12 Deliveries to reach sites during working hours between 07:30 and 15:30, unless otherwise agreed to by the Area Water Manager of the relevant Works.

8.13 Deliveries shall not exceed three months' supply at a time.

8.14 A certificate of analysis and exact quantity of each consignment shall accompany each delivery, failing which the delivery shall not be accepted.

8.15 A representative sample of each delivery shall be taken on site, in a suitable container provided by the supplier's driver, in the presence of both the driver and an official, for independent analysis by JGDM.

8.16 The supplier shall provide emergency contact details of a responsible person who can deal with any situation arising from a delivery or any other problem directly linked to the use of the chemicals supplied.

8.17 The supplier, supplier's driver or any employee of the supplier may in no circumstances work or handle pumps, valves or any Municipal property unless given permission by an official.

8.18 All delivery vehicles must be free from oil leaks as any vehicle with leaks will be denied access to the sites.

8.19 All suppliers delivering to our sites must adhere to JGDM's Security Procedures.

8.20 The Service Providers must deliver within 48 hours to seven (7) days of appointment, depending on the urgency of the chemical.

8.21 The Service Providers to deliver the required chemicals within 48 hours in emergency cases.

8.22 Upon delivery, letters of compliance Material Safety Data Sheets (MSDS) and certificates of analysis to be submitted with products.

9. Compliance with Safety Legislation:

9.1 The supplier shall be strictly in compliance with the Occupational Health and Safety Act 85 of 1993 and specifically with Regulation 7 of the General Administrative Regulations of the Occupational Health and Safety Act of 1993. Subject to provisions of section 10 (3) and (4) of the act, every person/ supplier who manufactures, imports, sells or supplies any hazardous chemical substances for use at work shall as far as reasonable practically provide the party receiving such substance, free of charge with a material safety data sheet all the information as contemplated in either ISO 11014 or ANSI Z400.1. 1993 with regard to:-

(a) Product and company identification;

(b) Composition /information or ingredient;

(c) Hazards identification;

(d) First-aid measures;

(e) Fire-fighting measures;

- (f) Accidental release measures;
- (g) Handling and storage;
- (h) Exposure control /personal protection;
- (i) Physical and chemical properties;
- (j) Stability and reactivity;
- (k) Toxicological information;
- (l) Ecological information;
- (m) Disposal consideration;
- (n) Transport information;
- (o) Regulatory information

GENERAL CONDITIONS OF CONTRACT

1. Definitions

The following terms shall be interpreted as indicated:

- 1.1 “Closing time”** means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 “Contract”** means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 “Contract price”** means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
- 1.4 “Corrupt practice”** means the offering, giving, receiving, or soliciting of any thing of the value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 “Countervailing duties”** are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 “Country of origin”** means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 “Day”** means calendar day.
- 1.8 “Delivery”** means delivery in compliance of the conditions of the contract or order.
- 1.9 “Delivery ex stock”** means immediate delivery directly from stock actually on hand.
- 1.10 “Delivery into consignees store or to his site”** means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 “Dumping”** occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 “Force majeure”** means an event beyond the control of the provider and not involving the provider’s fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 “Fraudulent practice”** means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 “GCC”** means the General Conditions of Contract.
- 1.15 “Goods”** means all of the equipment, machinery, and/or other materials that the provider is required to supply to the purchaser under the contract.

Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
2. The provider shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
3. Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the provider's performance under the contract if so required by the purchaser.
4. The provider shall permit the purchaser to inspect the provider's records relating to the performance of the provider and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights

- 6.1 The provider shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of goods or any part thereof by the purchaser.

1. When a provider developed documentation/projects for the municipality or municipal entity, the intellectual, copy and patent rights or ownership or such documents or projects will vest in the municipality or municipal entity.

7. Performance Security

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the provider's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or

- 8.4 If the inspections, tests and analyses referred to in clause 8.2 & 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the provider.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract supplies may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the provider who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do not comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the providers cost and risk. Should the provider fail to provide the substitute supplies forthwith, the purchaser may, without giving the provider further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the provider.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packaging

- 9.1 The provider shall provide such packaging of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packaging shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packaging, case size and weights shall take into consideration, where appropriate, the remoteness of the good's final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packaging, marking and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods and arrangements for shipping and clearance obligations shall be made by the provider in accordance with the terms specified in the contract.

11. Insurance

- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified.

12. Transportation

- 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified.

13. Incidental services

1. The provider may be required to provide any or all of the following services, including additional services, if any:
 - performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the provider of any warranty obligations under this contract; and
 - training of the purchaser's personnel, at the provider's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
2. Prices charged by the provider for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the provider for similar services.

14. Spare parts

- 14.1 As specified, the provider may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the provider:
- (a) such spare parts as the purchaser may elect to purchase from the provider, provided that this election shall not relieve the provider of any warranty obligations under the contract, and
 - (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) Following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

- 15.1 The provider warrants that the goods supplied under the contract are new, unused, of the most recent or current models and that, they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The provider further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the provider, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2 This warranty shall remain valid for thirty six (36) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise.
- 15.3 The purchaser shall promptly notify the provider in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the provider shall, within the period specified and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the provider, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the provider's risk and expense and without prejudice to any other rights which the purchaser may have against the provider under the contract.

16. Payment

- 16.1 The method and conditions of payment to be made to the provider under this contract shall be specified
- 16.2 The provider shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of a valid tax invoice or claim by the provider.
- 16.4 Payment will be made in Rand unless otherwise stipulated.

17. Prices

1. Prices charged by the provider for goods delivered and services performed under the contract shall not vary from the prices quoted by the provider in his bid, with the exception of any price adjustments authorized or in the

purchaser's request for bid validity extension, as the case may be.

18. Increase/decrease of quantities

- 18.1 In cases where the estimated value of the envisaged changes in purchase does not exceed 15% of the total value of the original contract, the contractor may be instructed to deliver the revised quantities. The contractor may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

19. Contract amendments

1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.

20. Assignment

- 20.1 The provider shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

21. Subcontracts

- 21.1 The provider shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the provider from any liability or obligation under the contract.

22. Delays in the provider's performance

- 22.1** Delivery of the goods and performance of services shall be made by the provider in accordance with the time schedule prescribed by the purchaser in the contract.
- 22.2** If at any time during performance of the contract, the provider or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the provider shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the provider's notice, the purchaser shall evaluate the situation and may at his discretion extend the provider's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 22.3** The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if any emergency arises, the provider's point of supply is not situated at or near the place where the supplies are required, or the provider's services are not readily available.
- 22.4 Except as provided under GCC Clause 25, a delay by the provider in the performance of its delivery obligations shall render the provider liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

- 22.5 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the provider's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the provider.

23. Penalties

- 23.1 Subject to GCC Clause 25, if the provider fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed good or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

24. Termination for Default

- 24.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the provider, may terminate this contract in whole or in part:
- (a) if the provider fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - (b) if the provider fails to perform any other obligation(s) under the contract; or
 - (c) if the provider, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 24.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the provider shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the provider shall continue performance of the contract to the extent not terminated.

25. Anti-Dumping and Counter-Vailing Duties and Rights

- 25.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the provider to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the provider in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

26. Force Majeure

- 26.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the provider shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 26.2 If a force majeure situation arises, the provider shall promptly notify the purchaser in writing of such condition and

the cause thereof. Unless otherwise directed by the purchaser in writing, the provider shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

27. Termination for Insolvency

27.1 The purchaser may at any time terminate the contract by giving written notice to the provider if the provider becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the provider, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

28. Settlement of Disputes

28.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the provider in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

28.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the provider may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.

28.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.

28.4 Notwithstanding any reference to mediation and / or court proceedings herein,

- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
- (b) the purchaser shall pay the provider any monies due to the provider for goods delivered and / or services rendered according to the prescripts of the contract.

29. Limitation of Liability

29.1 Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;

- (a) the provider shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the provider to pay penalties and / or damages to the purchaser; and
- (b) the aggregate liability of the provider to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

30. Governing Language

30.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

31. Applicable Law

31.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

32. Notices

- 32.1 Every written acceptance of a bid shall be posted to the provider concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 32.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

33. Taxes and Duties

- 33.1 A foreign provider shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 33.2 A local provider shall be entirely responsible for all taxes, duties, license fees, etc, incurred until delivery of the contracted goods to the purchaser.
- 33.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.

34. Transfer of Contracts

- 34.1 The contractor shall not abandon, transfer, assign or sublet a contract or part thereof without the written permission of the purchaser.

35. Amendment of Contracts

- 35.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.
