5. DOCUMENTATION

- 5.1 The original standard buying specification which accompanied order in the case of a single consignment or the final consignment of staggered deliveries.
- 5.2 A certificate of analysis stating all the results of the tests conducted by the supplier during manufacture and final acceptance.

The supplier's delivery note shall clearly state PMP's order number as well as PMP's code number.

- 6. PACKING
- 6.1 The Arabic gum must be supplied in sound, dry air tight containers of approved pattern, complying to statutory requirements.
- 6.2 The method of packing and the quantity to be supplied in each separate container shall be negotiated between the supplier and the purchaser.
- 6.3 When placing the order the purchaser shall stipulate the exact method of packing required. Any deviation from this method of packing as well as the inclusion of any foreign matter or impurities in any of the containers shall render the whole consignment liable to rejection.

SECTION B: QUALITY ASSURANCE

1. QUALITY ASSURANCE PROVISIONS

1.1 Responsibilities

- 1.1.1 The purchaser or his representative reserves the right of inspection of Laboratory Certificates as well as Production Quality Control Certificates of raw materials and components used for the manufacture of the applicable consignment of Arabic gum.
- 1.1.2 The supplier shall be responsible for making available to the purchaser all gauges and facilities necessary, if required, for the inspection of the Arabic gum.
- 1.1.3 The purchaser reserves the right at all times to audit the supplier's production facilities to ascertain whether quality requirements are being met.
- 1.1.4 The supplier will be responsible for the implimentation of the applicable quality management systems according to SABS 0157 to assure the appropriate quality of the product.

The total size of the manufacturing lot from which this sample was taken must also be indicated on the sample container.
