To ensure responsiveness to the notice Service Providers to take note of the following requirements (Compliance Evaluation):

- Service Providers must be registered on National Treasury's Central Supplier Database and submit a summary report as proof of registration or alternatively reflect the CSD supplier number on their proposal;
- All prospective/interested Service Providers should complete the MBD 4, MBD 6.1, MBD 7.1, MBD 8, MBD 9 and Declaration of Bidder forms which are appended to the notice document;
- 3. Bidders must meet the minimum requirements stipulated in section 7 below;

WEB HOSTING, MAINTENANCE AND SUPPORT OF THE WEBSITE FOR A PERIOD OF 12 MONTHS.

1. INTRODUCTION

The BCMDA is seeking the services of a qualified and competent service provider for hosting, maintenance, security and licensing of the BCMDA website. The service provider must also provide scalable hosting solutions that can accommodate our website's growth.

2. PURPOSE

The request for proposal (RFP) is issued to solicit proposals from suitable providers to submit proposals for the for the Web Hosting, maintenance and support of the BCMDA website portal for a period of 12 months.

3. SCOPE OF WORK

The successful bidders will be required to:

- a) Secure web Hosting Services x 12 months (South African based web host);
- b) Maintenance, Support and Training;
- c) Sufficient SSD disk space to facilitate growth of the website;
- d) 24/7 monitoring of the website against distributed denial of service (DDOS) attacks as well as the availability of the service;
- e) Hosting the website (HTML, PHP and MySQL etc.) locally in South Africa in a secure environment protected by an SSL certificate. The SSL certificate to be provided by the service provider;
- f) Have a Disaster Recovery facility in place where operations can continue with minimum interruption in an event of a disaster to the hosting data Center

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

 - (d) the intention or decision to submit or not to submit, a bid;
