## **TERMS OF REFERENCE FOR THE APPOINTMENT OF ACTUARIAL CONSULTANT TO PROVIDE THE POST-RETIREMENT MEDICAL AID LIABILITY VALUATION REPORT**

### **1. PURPOSE**

The South African Diamonds and Precious Metals Regulator ('the SADPMR) wishes to appoint actuarial consultant to provide the post-retirement medical aid liability valuation report.

### **2. BACKGROUND**

The South African Diamond and Precious Metals Regulator (SADPMR) is listed as a schedule 3A of the Public Finance Management Act. The SADPMR has a Remuneration policy which amongst others, has provision for retirees to claim all entitled benefits as outlined in the Government Employees Pension Law, 1996. Currently, the SADPMR's monthly contributions for medical aid divided as follows 66.5% paid by the entity and the retiree's portion is 33.5% towards medical aid premiums.

### **3. SCOPE OF WORK**

It is expected that the appointed qualified service provider will conduct an actuarial assessment for employees of the SADPMR who are currently on medical aid and qualify for post-retirement medical aid benefit.

### **4. DELIVERABLES**

- Actuarial assessment for a total number of 66 current and retired employees of the SADPMR who are currently on medical aid and are eligible for post-retirement medical assistance.
- Provide a comprehensive report of each individual liability that the SADPMR is responsible for as part of post-retirement medical aid liability.
- Selected service provider will be required to present the extensive report on post-retirement medical aid liability to the SADPMR.
- Provide recommendations (give options) regarding the selling off of the post-retirement medical aid liability to potential service providers

### **5. MONITORING AND REPORTING**

- The successful service provider will report directly to SADPMR Human Resources and Finance Divisions
- The HR and Finance Divisions for technical matters
- The SCM Division for terms of contract

#### **Cost**

- The service provider will be requested to provide a quote regarding the work to be undertaken for this project. The total cost must be VAT inclusive and should be quoted in South African currency (i.e. Rands). Detailed breakdown of the total bid must be attached.

#### **Broad-Based Black Economic Empowerment (B-BBEE)**

- Provisions of the Preferential Procurement Policy Framework Act (PPPFA) 2017 and its regulation will apply in terms of awarding points.
- Bidders are required to submit original and valid B-BBEE status level Verification to substantiate their B-BBEE rating claims.
- Bidders who do not submit their B-BBEE status level verification certificates or are non-compliant contributors to B-BBEE will not qualify for preference points for B-BBEE.
- In a case of Exempted Micro Enterprise (EMEs), AO/AA must ensure that the B-BBEE Status Level Verification Certificates submitted are issued by the following agencies:
  1. Verification agencies accredited by SANAS; or
  2. Registered auditors approved by IRBA

- iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 6.1, the contractor may be required to furnish documentary proof to the satisfaction of the purchaser that the claims are correct;
- iv) If the B-BBEE status level of contributor has been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the purchaser may, in addition to any other remedy it may have –
  - (a) disqualify the person from the bidding process;
  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) recommend that the bidder or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted by the National Treasury from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution.
