5. No Obligation to Proceed

The SABS reserves the right to discontinue the RFQ evaluation process at any time and will not be responsible for any losses incurred by the Bidder because of discontinuation of the RFQ process

6. Validity of Proposals

The Bidder's quotation shall remain valid for a period of one hundred and twenty (120) days from the closing date. The SABS may at any time prior to the expiry of the bid validity period, extend the above validity period by sixty (60) days by written notice to the Bidders. In that event, the SABS will not require any consent from the Bidders, and bidders will not be required or permitted to amend any of their quotations.

SABS retains the right, but is under no obligation, to request Bidders to extend the validity periods of their quotations, prior to expiry thereof, if it has already invoked the extension referred to above and it is in the SABS' interest to further extend the bid validity period. Such a request shall be in writing. The Bidder is not obliged to extend the validity period. Also, bidders will not be required or permitted to amend any of their quotations.

7. Scope of Work

SABS requires services of a consultant to assist with the revision of Bid Specification for the procurement of ERP system, which went to the market twice and declared non-responsive. The service of the Consultant will be amongst others:

- 1. Consideration and assessment of observations and recommendations from the Probity audit conducted during February 2026.**
- 2. Revision of mandatory and functional elements of the bid specification in line with Probity audit findings and best practice,**
- 3. Focusing bid specifications towards the implementation of Oracle Fusion Finance, SCM, and CRM modules, including system integration. Software license procurement will follow SITA OEC Framework.**
- 4. Provide assurance that revised specifications were benchmarked with at least three (3) successfully evaluated Oracle Fusion (or similar) implementation bids within the public sector.**
- 5. Generate a report to recommend an open tender bid specification for the implementation of Oracle Fusion at SABS to SABS bid specification committee.**
