Bids in sealed envelopes endorsed with the applicable bid number and the following heading “**SCM: 15/2023: SUPPLY AND DELIVERY OF TYRES, TUBES, WHEEL ALIGNMENT, TYRE REPAIR SERVICES AND BATTERIES**” must be placed in the **TENDER BOX** at the **Office of SUPPLY CHAIN MANAGEMENT UNIT, at the Sanlam Building, 112 DONKIN STREET, BEAUFORT WEST**, before the closing time and date of **14:00 on Friday, 17 November 2023**. Any person desiring to be present may attend.

Telegraphic, telephonic, telex, facsimile, e-mail, bids not completed in ink by hand and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and Beaufort West Municipality reserves the right to accept any part of the bid.

The bid must be valid for a period of 120 (one hundred and twenty) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, Preferential Procurement Policy, the Preferential Procurement Policy Framework Act, and the Preferential Procurement Regulations, 2022. Points will be allocated for the following specific goals: (a) contracting with persons, or categories of persons, historically disadvantaged by unfair discrimination on the basis of race, gender or disability; and (b) promotion of enterprises located in the municipal area (WC053).
