## 4 RFP INSTRUCTIONS

- 4.1 Please sign documents [sign, stamp and date the bottom of each page] before uploading them on the system. The person or persons signing the submission must be legally authorised by the respondent to do so.
- 4.2 **All returnable documents tabled in the Proposal Form [Section 5] must be returned with proposals.**
- 4.3 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.
- 4.4 Any additional conditions must be embodied in an accompanying letter. - 5.3 Respondents are to note that changes to its submission will not be considered after the closing date.
- 5.4 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Transnet in respect of this RFP between the closing date and the date of the award of the business.
- 5.5 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

## 6 CONFIDENTIALITY

All information related to this RFP is to be treated with strict confidence. In this regard Respondents are required to certify that they have acquainted themselves with the Non-Disclosure Agreement. All information related to a subsequent contract, both during and after completion thereof, will be treated with strict confidence. Should the need however arise to divulge any information related to this RFP or the subsequent contract, written approval must be obtained from Transnet.

## 7 COMPLIANCE

The successful Respondent [hereinafter referred to as the **Supplier/Service provider**] shall be in full and complete compliance with any and all applicable laws and regulations.

## 8 EMPLOYMENT EQUITY ACT

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

## 9 DISCLAIMERS

Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Transnet reserves the right to:

- 9.1 modify the RFP's Goods/Services and request Respondents to re-bid on any such changes;
- 9.2 reject any Proposal which does not conform to instructions and specifications which are detailed herein;
- 9.3 disqualify Proposals submitted after the stated submission deadline [closing date];
- 9.4 award a contract in connection with this Proposal at any time after the RFP's closing date;
- 9.5 award a contract for only a portion of the proposed Goods/Services which are reflected in the scope of this RFP;
- 9.6 split the award of the contract between more than one Supplier/Service provider, should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- 9.7 cancel the bid process;
- 9.8 validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so;

- 9.9 request audited financial statements or other documentation for the purposes of a due diligence exercise;
- 9.10 not accept any changes or purported changes by the Respondent to the bid rates after the closing date and/or after the award of the business, unless the contract specifically provided for it;
- 9.11 to cancel the contract and/request that National Treasury place the Respondent on its Database of Restricted Suppliers for a period not exceeding 10 years, on the basis that a contract was awarded on the strength of incorrect information furnished by the Respondent or on any other basis recognised in law;
- 9.12 to award the business to the next ranked bidder, provided that he/she is still prepared to provide the required Goods/Services at the quoted price, should the preferred bidder fail to sign or commence with the contract within a reasonable period after being requested to do so. ## 10 LEGAL REVIEW

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business. A material deviation from the Standard terms or conditions could result in disqualification.

## 11 SECURITY CLEARANCE

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the Goods/Services and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of **CONFIDENTIAL/ SECRET/TOP SECRET**. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

## 12 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Respondents must register on the CSD prior to submitting their bids. Business may not be awarded to a Respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD.

***For this purpose, the attached SBD 1 form must be completed and submitted as a mandatory returnable document by the closing date and time of the bid.***

## 13 TAX COMPLIANCE

Respondents must be compliant when submitting a proposal to Transnet and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).



It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations.

The Tax Compliance status requirements are also applicable to foreign Respondents/ individuals who wish to submit bids.

## SECTION 3: BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

### 1 BACKGROUND

Train Authorisation Equipment are safety critical systems that are used to authorize trains through the 'section' to prevent, rear end collision, 'head on' collisions, side collisions and derailments. Secondary to the primary requirement of safety, they also improve train service efficiency through the section to maximize track availability to allow more train slots.

Due to this safety requirement, Train Authorisation equipment are tested and approved before full deployment. "An approved list is utilized for Goods or Services that are required according to unique specifications, on a continual basis and from a limited number of suppliers."

This mechanism is used for non-standard items that are not available off the shelf. The purpose of this tender is to invite all interested parties with untested Signaling Equipment to participate in the testing of such Equipment with an aim of adding the Equipment on an existing approved list of suppliers for new installations, repairs and spares provision.

Following the nullification of the approved list in 2019, a RFP to frame/ reinstate the approved list was issued to the market in June 2020, not all bidders responded to the tender. This resulted in some of the previously tested and approved technologies not to be re-instated on the newly framed approved list. Through this RFP the suppliers of technologies that were previously tested and approved and were previously part of the old, approved list (2018/2019) are also invited to submit their bids as part of this tender. The said technologies will **not** be subjected to testing. Following the paper based exercise, and due diligence by Transnet to confirm same, such suppliers will be added onto the framed approved list with immediate effect. All suppliers proposing new technologies will be subjected to further Lab and field testing should they pass the paper based exercise.

### 2 EXECUTIVE OVERVIEW

Whereas Transnet is seeking a partner(s) to provide solutions for its Signaling Equipment nationally, it also seeks to improve its current processes for providing these Goods/Services to its end user community throughout its locations.

The selected Supplier/Service provider(s) must share in the mission and business objectives of Transnet. These mutual goals will be met by meeting contractual requirements and new challenges in an environment of teamwork, joint participation, flexibility, innovation and open communications. In this spirit of partnership, Transnet and its Supplier/Service provider(s) will study the current ways they do business to enhance current practices and support processes and systems. Such a partnership will allow Transnet to reach higher levels of quality, service and profitability.

Specifically, Transnet seeks to benefit from this partnership in the following ways:

- 2.1 Transnet must receive reduced cost of acquisition and improved service benefits resulting from the Supplier/Service provider's economies of scale and streamlined service processes.
- 2.2 Transnet must achieve appropriate availability that meets user needs while reducing costs for both Transnet and the chosen Supplier/Service provider(s).
- 2.3 Transnet must receive proactive improvements from the Supplier/Service provider with respect to supply/provision of Goods/Services and related processes.

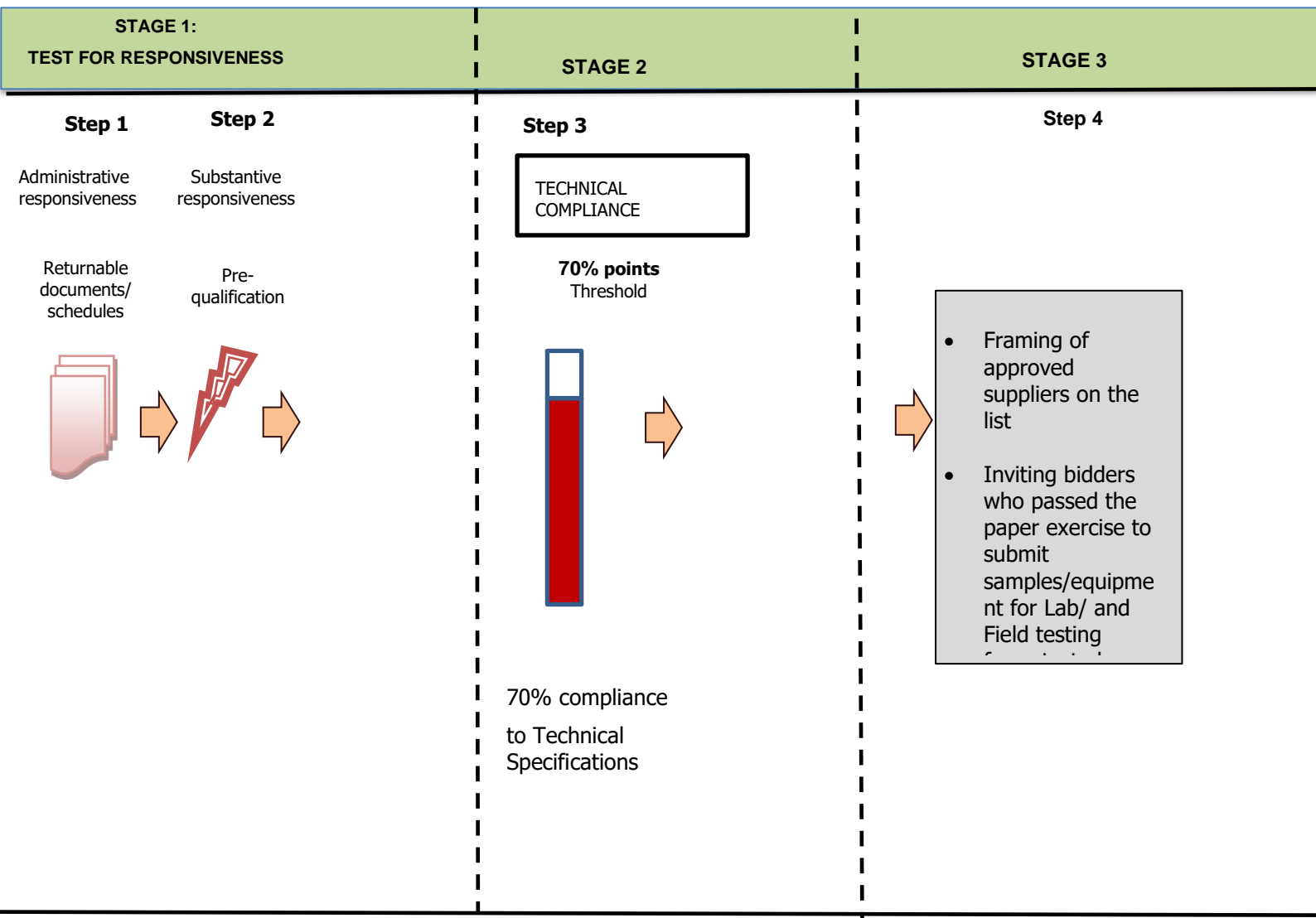

#### 6.4 **STEP FOUR: Testing (Lab and field Testing)**

##### **Lab and Field testing- for unapproved technologies**

The supplier is required to indicate if the product is supported by a warranty and the terms and conditions thereof must be clearly stated. Warranties will not be evaluated as part of the requirements to frame the approved list.

Unapproved products will undergo the complete testing and approval process as listed below:

- Supplier to provide detailed technical specifications, designs, drawings of proposed systems that the supplier has selected to tender for.
- Provide product samples to be tested by TFR TM in a TFR laboratory environment, where it is not possible to use a TFR Laboratory independent premises or the supplier's premises shall be utilised to perform the required testing under the following circumstances;

If the local supplier is not familiar with the technology, it is always ideal to conduct the lab setup at their facility where they have their skills available to address the following:

1. The technology under test may require additional equipment (e.g. Power supplies, communications interfaces, simulators, etc. which might not be available at a TFR lab).
2. TFR may not have the space for all the suppliers to set up their equipment.
3. May require suppliers have access to TFR facilities after-hours (risk).

4. Suppliers may have access to other supplier's products and know-how (IP risk).

- Design, Supply, Install and Pre-test the complete system and the relevant interfaces at a pilot site selected by Transnet Freight Rail for 'on-track testing' at the supplier's cost.
- Decommission the existing equipment and store it such that it can be re-instated after the completion of the 'on-track testing'.
- Perform first line maintenance on the system for the duration of the 'on-track' testing period.
- Provide all installation, maintenance and training manuals required.
- Provide Training to TFR personnel on maintenance and configuration.
- After the 'on-track' testing is complete, the supplier shall remove the piloted system and re-instate the original system at the suppliers cost.
- Should the pilot be successful, the supplier will be added onto the new TFR framed approved list.
- The approved system shall be rolled out as and when required by TFR, using the train authorisation systems approved list to approach bidders.

If quality improvements to the technology is required during the piloting period, the contractor will be allowed a total of four opportunities to comply with the requirement i.e. twice during laboratory testing and twice during 'on-track' testing. Should the contractor not comply with this requirement, it will be a disqualifying criteria. This is done to assist all those suppliers providing new technologies which are not yet matured and may need more than one opportunity to get them to a standard that fully complies with Transnet's requirements.

**Periodic quality tests on the systems framed on the approved list.**

It is a requirement that periodic tests be conducted to all systems/technologies that were previously tested, approved and subsequently framed on the approved list, including the systems that were framed based on experience, as such, Transnet undertakes to conduct standard periodic quality tests on a 12 month period for those technologies which are due for such tests based on their respective testing requirements to ensure an acceptable level of quality at all times. The frequency of the period tests differ from technology to technology. Through the said process all suppliers with technologies that are due for a periodic test will be requested to make the systems available or have such tests conducted in their premises where not possible to send to TFR. NB: Transnet however reserves the right to conduct these tests outside and beyond the 12 month period should it deem necessary to do so as informed by the requirements of the respective technologies

**Disclaimer:**

Transnet reserves the right to step outside of the approved list should none of the suppliers meet its requirements when called upon to do so at a particular point in time.

**Conditions for removal of names from the approved list**

The name of a bidders may be removed from an approved list at any time if the bidder:

## **SECTION 10: SBD 5**

### **THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME**

#### **INTRODUCTION**

The National Industrial Participation Programme (NIPP), which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIPP requirements. NIPP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade and Industry (DTI) is charged with the responsibility of administering the programme.

#### **1. PILLARS OF THE PROGRAMME**

- 1.1 The NIPP obligation is benchmarked on the imported content of the contract. Any contract having an imported content equal to or exceeding US\$5 million or other currency equivalent to US\$5 million will have a NIP obligation. This threshold of US\$5 million can be reached as follows:
  - (a) Any single contract with imported content exceeding US\$5 million.
  - or
  - (b) Multiple contracts for the same goods, works or services each with imported content exceeding US\$3 million awarded to one seller over a 2 year period which in total exceeds US\$5 million.
  - or
  - (c) A contract with a renewable option clause, where should the option be exercised the total value of the imported content will exceed US\$5 million.
  - or
  - (d) Multiple suppliers of the same goods, works or services under the same contract, where the value of the imported content of each allocation is equal to or exceeds US\$ 3 million worth of goods, works or services to the same government institution, which in total over a two (2) year period exceeds US\$5 million.
- 1.2 The NIP obligation applicable to suppliers in respect of sub-paragraphs 1.1 (a) to 1.1 (c) above will amount to 30% of the imported content whilst suppliers in respect of paragraph 1.1 (d) shall incur 30% of the total NIPP obligation on a *pro-rata* basis.
- 1.3 To satisfy the NIPP obligation, the DTI would negotiate and conclude agreements such as investments, joint ventures, sub-contracting, licensee production, export promotion, sourcing arrangements and research and development (R&D) with partners or suppliers.
- 1.4 A period of seven years has been identified as the time frame within which to discharge the obligation.

## 2. REQUIREMENTS OF THE DEPARTMENT OF TRADE AND INDUSTRY

- 2.1 In order to ensure effective implementation of the programme, successful bidders (contractors) are required to, immediately after the award of a contract that is in excess of **R10 million** (ten million Rands), submit details of such a contract to the DTI for reporting purposes.
- 2.2 The purpose for reporting details of contracts in excess of the amount of R10 million (ten million Rands) is to cater for multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as provided for in paragraphs 1.1.(b) to 1.1. (d) above.

## 3. BID SUBMISSION AND CONTRACT REPORTING REQUIREMENTS OF BIDDERS AND SUCCESSFUL BIDDERS (CONTRACTORS)

- 3.1 Bidders are required to sign and submit this Standard Bidding Document (SBD 5) together with their bid documentation at the closing date and time of the bid.
- 3.2 In order to accommodate multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as indicated in sub-paragraphs 1.1 (b) to 1.1 (d) above and to enable the DTI in determining the NIPP obligation, successful bidders (contractors) are required, immediately after being officially notified about any successful bid with a value in excess of R10 million (ten million Rands), to contact and furnish the DTI with the following information:
