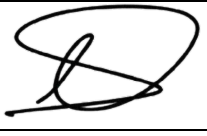

1. Scope of Work

This specification requirement covers all the requirements that will be needed to inform the supplier to carry out what is expected from him/her: The contract will be awarded as a Hygiene Service Project, and the contractor will be responsible for all the work specified.

This specification states the minimum requirements relating to the work and in no way absolves the contractor from responsibility for Hygiene services. Any omissions or sub-standard requirements of this specification must be brought to the attention of Transnet Engineering Depots at tender stage and optional prices for addressing such omissions must be provided.

The Supplier shall supply all the Labour, Tools, Material, Equipment, Consumables, Facilities, Inspection and supervision required for the supply of the specified Hygiene Services for the duration of 36 months contract.

This tender will be evaluated and awarded per grouping as per the below:

Group 1 :

Postmasburg , Upington , De Aar , Lime Acres

Group 2 :

Kimberley (Wagons and Locos)

Group 3 :

Bloemfontein (Wagons and Locos)

2. Information Required

Tenderers shall confirm that the items that they are offering comply at a standard not less than the minimum required requirement asked for in the specifications. Tenderers must comply to these specifications, but alternative offers may, in addition, also be submitted. Such alternative offers must be fully motivated and substantiated under the price schedule.

3. Regulations and Standards:

Comply with the Occupational Health and Safety Act (Act85 of 1993), as amended and its Regulations.

The contractor to have a SAFETY FILE, on site at all times.

The contractor shall submit the SAFETY FILE before commencing of the project with following mandatory documents but not limited to; Valid Letter of Good standing from compensation commissioner, medical fitness certificates from Occupational Medical Practitioner for all employees, Training certificates regarding the type of work to be performed e.g., HCS training, First Aid, SHE Rep, Incident Investigator, Risk Assessor and covid-19 related training etc. Company Organogram, SHE Inspections checklists, Company Profile, SHEQ Management Plans including Emergency plan, Risk Assessment with Method statement, Procedures, Legal Appointment letters and Incident management Procedures and Processes.

4.1.2	The equipment will remain with Transnet at the end of the contract.

5.1.1	Supply and Installation of Wall Mounted Automatic Hand Dryer , 2.3kW minimum , Stainless Steel(Grade 304 minimum) , Sensor to have range of 100mm – Bidders are to provide the maintenance manual with the tender submission	
5.2	Wall Bin (Once off)	Comply Yes/No
5.2.1	Supply and Install wall mounted bins manufactured from ABS or Similar Polymer Based Material or similar polymer based material - Size= 18 Liter , White Finish	
5.2.2	Unit must not be fitted with a lid.	
5.3	Liquid Soap Dispenser (Once off)	Comply Yes/No
5.3.1	Supply and installation of Wall Mounted Soap Dispensers (1 Liter - Manufactured from ABS Plastic) -Refillable	
5.3.2	Dispenser must have a cartridge system	
5.3.3	Push mechanism must as such that unit cannot be "pulled from the wall".	
5.3.4	Unit must have a hidden locking mechanism to prevent pilferage of soap.	
5.3.5	Unit must be fitted flush with wall to allow for easy wipe down.	
5.3.6	Unit must have a large view window that allows for at-a-glance maintenance.	
5.3.7	The pump mechanism must be easy to replace if defective.

5.4.1	Supply and installation of Seat Wipes Dispenser (ABS or Similar Polymer Based Material- to hold 30 Wipes at a time)	
5.4.2	Must be suitable for use with single or double ply, multi-fold toilet tissue.	
5.4.3	Hands to paper dispensing, the user must not come in contact with the unit.	
5.5	Toilet Roll Holder (Once off)	Comply Yes/No
5.5.1	Supply and installation of Toilet Roll Holder (3-Roll Stainless Steel - with lock mechanism - Key and Lock Mechanism included) - WxHxD: 130 x 390 x 140mm	
5.5.2	Easy access for re-filling.

5.6.1	Supply and installation Air Freshener Dispenser (Auto) - Sized on a 30-Day Cycle - 3000 Sprays per refill, white finish, ABS or similar polymer-based material	
5.6.2	Enhancer must use the Micro Trans and Microburst Technology to neutralise odours, rather than masking them.	
5.6.3	Must be possible to use various fragrances.	
5.7	S.H.E. Bin (Sanitary) (Once off)	Comply Yes/No
5.7.1	Supply and installation of SHE Bins (Once off) 19 litre hard plastic and stain resistance pedal design with a central opening for optimum capacity. White Color

7.1	General Information:	Comply Yes/No

7.1.1	Tenderer must service the equipment on a regular basis to allow for proper operation. The equipment must be maintained and be replaced within 48 hrs when defects are noted. This is only in the case where the defect is due to the quality of the equipment and not if the equipment is damaged due to negligence.	
7.1.2	The Contractor shall provide Transnet with the Material safety data sheet for the chemicals to be used.	
7.1.3	The Contractor shall provide Transnet with the Risk Assessment prior the commencement	
7.1.4	Contract will be terminated if Transnet is not satisfied with service provided.
