# REQUEST FOR PROPOSAL (RFP): SUPPLY & INSTALLATION OF A FLEET TRACKING AND MONITORING SYSTEM, FOR A CONTRACT PERIOD OF 36 MONTHS

#### **Section T1.1: Tender Notice and Invitation to Tender**

#### 1. Background

Bloem Water is a Water Board, with the mandate to provide water services to the areas of the Free State and Northern Cape Provinces. Bloem Water, formerly known as the Bloem Area Water Board, was established in 1991 in terms of Section 108(2) of the Water Act, 1956. The primary reason for establishing the Water Board was to operate the Caledon/Bloemfontein Government Water Scheme, constructed to supply purified water to the Municipal areas of Bloemfontein, Bainsvlei, Bloemspruit, Botshabelo and Dewetsdorp. The name was officially changed from "Bloem Area Water Board" to "Bloem Water" in 1994.

Bloem Water derives its primary mandate from the Water Services Act 108 of 1997 and is in terms of the Public Finance Management Act (PFMA), Act 1 of 1999, Schedule 3B, a National Government business entity, which reports to the Executive Authority, represented by the Minister of Water and Sanitation through the Department of Water and Sanitation (DWS).

# 2. Bloem Water specific goals

In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

Bloem Water accordingly invites suitably qualified and experienced Service Providers to submit proposals to Bloem Water for the following:

#### 3. Scope of Work

Bloem Water hereby invites tenders from suitably qualified and experienced Professional Service Providers are invited to submit proposals for Supply & Installation of a Fleet Tracking and Monitoring System. The bidders should be experienced in rendering insurance services to public entities or government institutions and have a soundtrack record of work of a similar nature. Bidders are requested to attach proof of the above on the respective company letterhead. The contract period is for Thirty Sixty months (3 years).

#### The scope of work includes and addresses the following:

- 1. Driver Identification
  - a. Prevent the vehicle from starting if driver is not authorised to drive the vehicle and/or if not in their Code Class
  - b. Users/supervisor to have the ability to authorise from a secure web-based platform.
- 2. The system should allow authorise users to prevent the vehicle from starting / immobilise the vehicle at any given time.
- 3. Each vehicle should be fitted with an assist button which is linked to a 24/7/365 control room.
- 4. All exception notifications must be sent to key personal like Supervisors and Fleet Controllers.
- 5. List available exception notifications.
- 6. Fleet tracking and monitoring platform should be securely hosted and web-based with the option to host at Bloem Water.
- 7. The supplier shall provide software maintenance and upgrades for the duration of the contract.
- 8. All data to be securely stored by the supplier for the duration of the contract, thereafter data will be transferred to the Bloem Water server.
- 9. Users should have access to track and trace vehicle via a mobile app, including Android and IOS.
- 10. The supplier shall provide 24/7/365 Stolen Vehicle Recovery within South Africa and neighbouring countries.
  - a. Cross border tracking.
- 11. The system should be able to poll any vehicle at any given time.
- 12. Vehicle reporting intervals should be no more than 30 seconds.

#### 13. Operating areas

- a. Unlimited geo-zones
- b. Notifications on entering and leaving these geo-zones
- 14. Bloem Water requires an automated daily health check on all vehicles and device status as well as an response on devices not reporting.
- 15. Notifications on any tampering and unauthorised usages. User should have access to immobilise these vehicles if need be.
- 16. The device should be able to detect accident as well as provide a full accident report of the incident.
- 17. The system should report on fuel theft and monitoring.
- 18. 24/7/365 Roadside and Emergency assistance.
- 19. The hardware and software should carry a 36 month warranty.
- 20. Bloem Water currently have 600 vehicles which consists of Sedans, Minibuses, Busses, LDVs, Trucks, Yellow Plant, Trailers, Mobile Pumps and Mobile Generators.
- 21. Secondary un-jammable device to be fitted to each vehicle and trailer.
- 22. All devices should be Insurance approved.

#### Required Qualifications/Evaluation of Bids:

Preference will be given to Service Providers who demonstrate previous expertise in the relevant field, capabilities, and have the required qualified human resources and expertise. The prospective service providers must demonstrate competency, mention experience and attach a list of projects they have successfully completed of a similar nature and demonstrate sound ability for project Implementation.
