1. INTRODUCTION.

Gateway Airport Authority Limited (GAAL) seeks to appoint a suitably qualified, reputable, and experienced service provider for supply of compatible Firefighting Foam concentrate and Chemical Dry Powder at Airport Polokwane International Airport.

Airport is therefore required to appoint a service provider who must be able to demonstrate acquittance with the provision of compatible Firefighting Foam concentrate and Dry Chemical Powder through references and proof of supply to other similar firefighting institutions, as per the scope of work below.

2. SCOPE OF WORK
