## **SPECIAL INSTRUCTIONS AND NOTICES TO BIDDERS REGARDING THE COMPLETION OF BIDDING FORMS**

**PLEASE NOTE THAT THIS BID IS SUBJECT TO TREASURY REGULATIONS 16A ISSUED IN TERMS OF THE PUBLIC FINANCE MANAGEMENT ACT 1999, THE MPUMALANGA SUPPLY CHAIN MANAGEMENT POLICY FRAMEWORK AND THE GENERAL CONDITIONS OF CONTRACT.**

1. Unless inconsistent with or expressly indicated otherwise by the context, the singular shall include the plural and vice versa and with words importing the masculine gender shall include the feminine and the neuter.
2. Under no circumstances whatsoever may the bid forms be retyped or redrafted. Photocopies of the original bid documentation may be used, but an original signature must appear on such photocopies.
3. The bidder is advised to check the number of pages and to ensure that none are missing or duplicated.
4. Bids submitted must be complete in all respects.
5. Bids shall be lodged at the address indicated not later than the closing time specified for their receipt, and in accordance with the directives in the bid documents.
6. Each bid shall be addressed in accordance with the directives in the bid documents and shall be lodged in a separate sealed envelope, with the name and address of the bidder, the bid number and closing date indicated on the envelope. The envelope shall not contain documents relating to any bid other than that shown on the envelope. If this provision is not complied with, such bids may be rejected as being invalid.
7. All bids received in sealed envelopes with the relevant bid numbers on the envelopes are kept unopened in safe custody until the closing time of the bids. Where, however, a bid is received open, it shall be sealed. If it is received without a bid number on the envelope, it shall be opened, the bid number ascertained, the envelope sealed and the bid number written on the envelope.
8. A specific box is provided for the receipt of bids, and no bid found in any other box or elsewhere subsequent to the closing date and time of bid will be considered.
9. No bid sent through the post will be considered if it is received after the closing date and time stipulated in the bid documentation, and proof of posting will not be accepted as proof of delivery.
10. No bid submitted by telefax, telegraphic or other electronic means will be considered.
11. Bidding documents must not be included in packages containing samples. Such bids may be rejected as being invalid.
12. No alterations will be allowed, any alterations added to the document will lead to disqualification.

## **1. INTRODUCTION**

The Independent Development Trust (IDT) is a Schedule 2 Public Entity governed by its Deed of Trust, the Public Finance Management Act (Act No. 1 of 1999), as amended by Act of No. 29 of 1999 (PFMA) and other relevant legislative frameworks. The IDT is mandated to support government in development programmes implementation across the three spheres of government. Its primary focus is on social infrastructure programme delivery management, i.e. schools, hospitals, courts, etc.

### **Legislative Framework**

All bidders must comply with applicable South African legislation, including but not limited to:

Occupational Health and Safety Act 85 of 1993

Public Finance Management Act

Construction Regulations 2014 (where applicable)

National Building Regulations and SANS 10400

Applicable municipal by-laws and fire safety regulations

## **2. CONTEXT**

The IDT is a Schedule 2 State owned entity which manages the implementation and delivery of critically social infrastructure programmes on behalf of government. The IDT is committed to ensuring the implementation of the Codes of Good Practice. The IDT reports to the Minister of Public Works and Infrastructure who is a Shareholder representative and its Executive Authority. The IDT's national office is located in Pretoria and has regional offices in all of the country's nine provinces

## **3. PURPOSE**

The purpose of this bid is to find suitable Office space for the IDT MPUMALANGA Regional Office based in NELSPRUIT.

## **4. BUILDING SPECIFICATION:**

### **4.1 OFFICE LOCATION**

The bid shall include costing for both common areas specification requirement and lettable space requirement and parking bays as listed below: -

- IDT requires office space for its Mpumalanga Regional Office based in Nelspruit.
- The office accommodation should be at least 10km radius from CBD

#### **4.2. Premises Accessibility**

The premises must be within the vicinity of Public Transport amenities.

#### **4.3 Office Space Requirements**

- The office must be accessible by disabled persons and conform to SANS 10400 Part T and S for disabled persons
- The office space needs to be at least 428 square metres of lettable space as measured by the SAPOA method of measuring and calculating spaces, with 20 covered parking bay for staff and 15 visitors parking spaces
- The Office must be well secured with access control, to accommodate a total number of 30 staff members.
- The offices must provide a total number of suitable toilet seats which are lockable for both males and females and 1 separate ablution facility to make a provision for disabled persons as per part P and Part S of SANS 10400: (2 seats and 2 urinals for males. 4 seats for females)
- Fully functioning energy efficient Air conditioning system must be provided in all tendered space.
- Offices should have sufficient ventilation by means of HVAC and natural air in line with labour legislations.
- The offices must have an uninterrupted power supply (to power the server room, network system and telephone lines).
- Landlord must be willing to allow IDT branding to be mounted on the outside of the building
- The building offered must be habitable for office use and the bidder must be open for negotiation with IDT for Tenant Installation Allowance.
- It must be in close to public transport system, within a corporate zoned area with adequate parking away from the CBD, industrial and retail outlets.
- The building must be compliant and in good working condition creating a conducive environment.
- The office must be well secured with access control, to accommodate a minimum number 30 staff.
- The office must be user friendly to people with disabilities and include ramps and or lifts where necessary to conform to SANS 10400-part P and S for people living with disabilities.
- The building must have suitable facilities such as lights, air-conditioning and a serviced lift if not on the ground floor.
- The building must have an adequate number of lifts where applicable
- The building must have a 24-hour security for the office building and parking areas.
- Grade B building or higher in terms of SAPOA office grading definitions.

- Regulated /controlled vehicular and pedestrian entrance and exit (with guard house
- The Landlord must be will to allow IDT branding to be mounted on the outside of the building.
- Both parties will sign a 36 months Lease Agreement with an option of 24 months extension.
- Termination Clause of one (1) month notice must be included.
- If the bidder proposes to refurbish the exiting building, the bidder should submit the following documents:
  - a) Floorplans of the building or space being offered.
  - b) Commitment letter to refurbish the building as per the tenant specification with a Tenant Installation amount.
  - c) Partitioning as per IDT's specification
  - d) Air-conditioning (preferably split units) e) Painting - with corporate colours
  - e) Floor covering - with corporate colours
  - f) Power skirtings - with two power plugs per work station
  - g) Network and telephone points.
  - h) Blinds - with corporate colours.
  - i) Space plan.
  - j) UPS facility integrated into specific plug points.

#### **4.1. Price schedules including VAT detailing: -**

The price inclusive of VAT for the duration of contract must be inclusive of:

- 36 Monthly rental fees for the office space and parking bays must be separated from the monthly utility fee. The total rental amount for the 36 months must be carried to form of offer section which will be used for price and specific goal evaluation.
- Separate pricing monthly rental fee for further 24 months in case IDT decide to extend the lease contract for further 24 months. The additional 24 months' total amount MUST NOT be included in the form of offer section.
- The applicable annual escalation rate must be indicated for each year.
- All building maintenance related costs, including all fixed equipment.
- IDT reserves the right to extend the initial 36 months' contract period by further 24 months.

## Rental Deposit / Security Rental Deposit and Security Requirements

Bidders are hereby informed that, in line with public sector procurement frameworks and leasing practices applicable to government institutions, the inclusion of a rental deposit is not a standard requirement for this tender.

In this regard:

The Independent Development Trust (IDT), as a public entity, operates within the procurement framework prescribed by the National Treasury and the Department of Public Works and Infrastructure (DPWI), including the Public Finance Management Act, 1999 (Act No. 1 of 1999) and applicable Supply Chain Management (SCM) prescripts.

In terms of these frameworks, all material commercial terms must be clearly defined at the tender stage to ensure a procurement system that is fair, equitable, transparent, competitive, and cost-effective.

Accordingly:

No rental deposit shall be payable under this tender unless explicitly stated otherwise in the bid documentation.

Bidders are required to price and submit their proposals on the basis that no deposit will be claimed or payable by IDT.

Any proposal submitted with conditions relating to a rental deposit, not provided for in this tender, may be deemed non-responsive.

Notwithstanding the above, the IDT reserves the right to incorporate appropriate risk mitigation measures within the lease agreement, including but not limited to:

- Clearly defined payment terms aligned to government payment processes;
- Interest on overdue payments, where applicable;
- Maintenance, damages, and reinstatement obligations; and
- Dispute resolution and escalation mechanisms.

Bidders are further advised that no material changes to the commercial terms, including the introduction of a rental deposit, will be permitted post-award, as this may constitute a deviation from the approved Terms of Reference and may not be compliant with applicable procurement prescripts.

Bidders must provide physical address of the office space tendered for inspection purposes before the evaluation process is finalized.

## **5. ACCESS TO LEASED PROPERTY**

The proposed leased property must be made available and to be in good condition and clean at least 21 days before occupation and 21 days after occupation date.

## **6. PROOF OF OWNERSHIP**

The bidder must be the owner of the property and proof of ownership of the proposed properties must be submitted together with the bid documents. In case where the agent has been appointed to manage the property and to submit the bid, the power of attorney or any acceptable written proof of appointment as an agent must be provided with the bid together with the proof of ownership with the proposed property. Years of experience must correspond with registration date of the company.

## **7. PENDING LITIGATIONS**

All bidders must provide details of all pending litigations (especially interdicts) relating to the proposed property and land if any.

## **8. PARTITIONING OF THE OFFICES:**

Partitioning of the offices in line with the requirement of the IDT will be the responsibility of the landlord as per the requirement provided for by the IDT. The partition should be completed before the IDT takes occupation.

### **Post-Award / Pre-Occupation Requirements**

The successful bidder will be required, prior to occupation, to submit the following:

OHS Compliance File

A comprehensive OHS file, which may include:

- Risk assessments
- Emergency evacuation plans
- Incident management procedures
- Proof of maintenance of safety systems

Valid Electrical Compliance Certificate must be submitted together with the Bid Document

## **9. OCCUPATION DATE**

## 9. CONDITIONS:

- Office Location: The office premises should be situated in NELSPRUIT (within the zoned corporate office park, away from retail shops, Industrial and Central Business District (CBD) with accessible public transport system.
- The lease agreement will be for a period of 3 years, planned to be effective from 01<sup>st</sup> July 2026 or as and from when the agreement is concluded. The IDT reserves the right to extend the contract for further 24 months and bidders will be required to provide monthly rental for year 4 and 5 in case IDT decide to exercise right to extend.

**The service provider will be required to:**

- Enter into a lease agreement with the IDT.
- Demonstrate and sustain quick response in terms of compliant with regards structural related issues such as the conditions of the building, roof leakages, structural defects and any building maintenance required etc.
- Have the ability to provide secure and covered parking bays
- It is the Service Provider’s responsibility to provide monthly rental and utility bill invoice by the 25th day of each month to be paid end of the month.
- The service provider must be available for an annual review of its services in term of structural challenges etc.

**10. BID VALIDITY**

The bidder is required to confirm that it will hold its proposal valid for 90 days from the closing of the tender, during which time it will maintain without changing their proposed rates and prices.

**11. TARRIFS/ DISCOUNT ADJUSTMENTS**

The successful bidder must indicate annual escalations adjustments in the bid document if any. Industry range requires between 6% to 8% increase annually. **NB. The increase will only apply from the second year of the lease agreement.**

**12. TRANSACTION / SERVICE FEES**

The successful bidder must submit a detailed breakdown of service fees per month. (rental, utility bills, parking, sewerage, refuse removal, rates and taxes). An indication of Value Added Tax (VAT) must be explicitly clear on the fees. The costing structure must be clearly indicated.

#### 14. SHORTLISTED BIDDERS MAY BE REQUIRED TO:

- 14.1. Make a presentation to the IDT when required to do so;
- 14.2. Demonstrate professionalism in letting management, as well as flexibility in accommodating the IDT's specific needs
- 14.3. Demonstrate and confirm the ability to deal with emergency situations within 24 hours in terms of serious structural defects such as roof leakages, roof tile replacement, blocked toilet, burst water pipes, burst geysers etc.;
- 14.4. Prompt response to all maintenance related issues;
- 14.5. Access control and 24/7 physical security with reputable and experience security company.

## 15. RESPONSIBILITIES OF THE SERVICE PROVIDER

The shortlisted bidder must arrange relevant site inspection of the property however the IDT reserves the right to conduct such visits in the absence of the successful bidder; this will be noted and collated to a formal snag list and kept for record purposes.

## 16. REQUIRED KNOWLEDGE, SKILL AND EXPERTISE

- 16.1. The service provider must have proficient knowledge and experience in the following areas: -
- 16.2. Knowledge and understanding of corporate office space and cotemporary space planning methodologies;
- 16.3. Understanding of National Building regulations.

## 17. PROCUREMENT APPROACH

- 17.1. The required services shall be procured through a Bidding Process, as per the IDT SCM policy and procedures.
- 17.2. Bids submitted by means of e-mail, facsimile, electronic or similar means shall not be considered. Only bids submitted in hard copies will be accepted.
- 17.3. Tender submissions will require at a minimum the following:
  - Executive summary;
  - Approach to property management;
  - Indication of technical and support systems;
  - Description and breakdown of similar work executed successfully; and
  - Tender price for 36 months with an option to extend 24 months (clearly outlining the disaggregated costing per activity and sum up to the total price).

17.3.1 Bidders who meet the requirements for submission of mandatory returnable documents may be invited to make presentations to the Bid Evaluation Committee (BEC).

## 18. EVALUATION PROCESS

- 18.1. Bid/Tender will be evaluated in accordance with the IDT's Supply Chain Management Policy, which conforms to the provisions of the Preferential Procurement Policy Framework Act and its Regulations.
- 18.2. The tender evaluation criteria, in line with the IDT Supply Chain Management Policy, will be as follows:
  - **Phase1:** Compulsory requirement;
  - **Phase 2:** Functionality Bidder to score a total of 70 functionality points out of 100;
  - **Phase 3:** 80/20 Price and Preference Point system will be used where 80 points is for price and 20 points is for Specific Goals as cited above. A bidder that scores less than 70% of total functionality points will not be further evaluated.
- 18.3. Preference points for Specific Goals as stipulated in the criteria.

18.4. For purposes of comparison and in order to ensure a meaningful evaluation, bidders are requested to furnish detailed information to substantiate their bid.

## **19. EVALUATION CRITERIA**

The bid will be evaluated on the following three phases:

### **19.1. Phase 1: Responsive criteria**

All bids will be evaluated on the responsive criteria to determine compliance with the following mandatory documents:

- Certified copy of deed registration ownership/Power of Attorney/ Subletting agreement (refer to item 6 above)
- Company profile with a list of current or previous clients serviced by your firm

- Return late tenders** 3 Tenders will be deemed late if they are not in the designated tender box at the date and time stipulated as the deadline for tender submission.
- Tender opening** 4 Open the tenders in the presence of the *tenderers'* representatives who choose to attend at the time and place stated in the Tender Data.
- Non-disclosure** 5 Not disclose to *tenderers*, or to any other person not officially concerned with such processes, information relating to the evaluation and comparison of tenders and recommendations for the award of a contract.

**Disqualification** 7 Instantly disqualify a *tenderer* (and his tender) if it is established that the *tenderer* offered an inducement, gift or bribe to any person with a view to influencing the placing of a contract arising from this invitation to tender. Such tenderer may be restricted from doing business with the IDT and/or the State.

**Test for responsiveness** 8 Determine before detailed evaluation, whether each tender properly received

- meets the requirements of these Conditions of Tender,
- has been properly signed, and
- Is responsive to the requirements of the *tender documents*.

9 Judge a responsive tender as one which conforms to all the terms, conditions, and specifications of the *tender documents* without material deviation or qualification. A material deviation or qualification is one which, in Independent Development Trust's opinion would:

- detrimentally affect the scope, quality, or performance of the works, services or supply identified in the Contract Data,
- change Independent Development Trust's or the *tenderer's* risks and responsibilities under the contract, or
- affect the competitive position of other *tenderers* presenting responsive tenders, if it were to be rectified.

**Non-responsive tenders** 10 Reject a non-responsive tender.

**Arithmetical errors** 11 Check responsive tenders for arithmetical errors, correcting them as follows:

- Where there is a discrepancy between the amounts in figures and in words, the amount in words shall govern.
- Where there is an obviously gross misplacement of the decimal point in the rate, the line item total as quoted shall govern, and the rate will be corrected.
- Where there is an error in the total of the Prices, either as a result of other corrections required by this checking process or in the *tenderer's* addition of prices, the total of the Prices, if any, will be corrected.

12 Reject a tender if the *tenderer* does not accept the corrected total of the Prices (if any).

**Grounds for rejection** 6 Consider rejecting a tender if there is any effort by a *tenderer* to influence the processing of tenders or contract award.

## General Conditions of Contract

### 1. Definitions

1. The following terms shall be interpreted as indicated:

- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.

- 1.11 "Dumping" occurs when a private enterprise abroad market its goods  
1.12 on own initiative in the RSA at lower prices than that of the country of origin  
and which have the potential to harm the local industries in the
- 1.13 1.12" Force majeure" means an event beyond the control of the supplier  
and  
1.14 not involving the supplier's fault or negligence and not foreseeable. Such  
events may include, but is not restricted to, acts of the purchaser in its  
sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine  
restrictions and freight embargoes.
- 1.15 "Fraudulent practice" means a misrepresentation of facts in order to  
1.16 influence a procurement process or the execution of a contract to the  
detriment of any bidder, and includes collusive practice among bidders  
(prior to or after bid submission) designed to establish bid prices at artificial  
non-competitive levels and to deprive the bidder of the benefits of free and  
open competition.
- 1.17 "GCC" means the General Conditions of Contract.
- 1.18 "Goods" means all of the equipment, machinery, and/or other materials that  
the supplier is required to supply to the purchaser under the contract.
- 1.19 "Imported content" means that portion of the bidding price represented by  
the cost of components, parts or materials which have been or are still to  
be imported (whether by the supplier or his subcontractors) and which costs  
are inclusive of the costs abroad, plus freight and other direct importation  
costs such as landing costs, dock dues, import duty, sales duty or other  
similar tax or duty at the South African place of entry as well as  
transportation and handling charges to the factory in the Republic where  
the supplies covered by the bid will be manufactured.
- 1.20 "Local content" means that portion of the bidding price which is not included  
in the imported content provided that local manufacture does take place.
- 1.21 "Manufacture" means the production of products in a factory using labour,  
materials, components and machinery and includes other related value  
adding activities. 1.19 "Order" means an official written order issued for the  
supply of goods or works or the rendering of a service.
- 1.22 "Project site," where applicable, means the place indicated in bidding  
documents.
- 1.23 "Purchaser" means the organization purchasing the goods.

1.24 “Republic” means the Republic of South Africa.

1.25 “SCC” means the Special Conditions of Contract.

1.26 “Services” means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such 6 obligations of the supplier covered under the contract.

1.27 “Written” or “in writing” means handwritten in ink or any form of electronic or mechanical writing.

## **2. Application**

2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.

2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.

2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

## **3. General**

3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.

**3.2 The IDT will develop Special Conditions of Contract for the appointed bidder.**

## **4. Standards**

4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

## **5. Use of contract documents and information, inspection.**

5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.

5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.

5.3 Any document, other than the contract itself mentioned in GCC clause shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.

5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser

## **6. Patent rights**

6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

## **7. Performance security**

7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.

7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.

7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:

(a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or

(b) a cashier's or certified cheque

7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

## **8. Inspections, tests and analyses**

8.1 All pre-bidding testing will be for the account of the bidder.

8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.

8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.

8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.

8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.

8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.

8.7 Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal, the rejected supplies shall be returned at the suppliers cost and risk. Should

the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.

8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

## **9. Packing**

9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.

9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

## **10. Delivery and documents**

10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.

10.2 Documents to be submitted by the supplier are specified in SCC.

## **11. Insurance**

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

## **12. Transportation**

12.1 Should a price other than an all-inclusive delivered price be required this shall be specified in the SCC.

### **13. Incidental services**

13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:

- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied goods; (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

### **14. Spare parts**

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and (b) in the event of termination of production of the spare parts:
  - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
  - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

### **15. Warranty**

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may

develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (06) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

## **16. Payment**

16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.

16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.

16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.

16.4 Payment will be made in Rand unless otherwise stipulated in SCC.

**17. Prices** 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.

## **18. Contract amendments**

18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.

## **19. Assignment**

19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

## **20. Subcontracts**

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

## **21. Delays in the supplier's performance**

21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.

21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.

21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.

21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause

21.2 without the application of penalties.

21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to

complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

## **22. Penalties**

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

## **23. Termination for default**

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (i) the name and address of the supplier and / or person restricted by the purchaser;
- (ii) the date of commencement of the restriction
- (iii) the period of restriction; and (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

## **24. Anti-dumping and countervailing duties and rights**

24.1 When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a provisional payment or antidumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such antidumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him

## **25. Force Majeure**

25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

## **26. Termination for insolvency**

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

## **27. Settlement of Disputes**

27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.

27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.

27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.

27.5 Notwithstanding any reference to mediation and/or court proceedings herein,

- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
- (b) the purchaser shall pay the supplier any monies due the supplier.

## **28. Limitation of liability**

28.1 Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;

(a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

(b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

## **29. Governing language**

29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

## **30. Applicable law**

30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.

**31. Notices** 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice

31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

## **32. Taxes and duties**

32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.

32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.

32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance

certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.

### **33. National Industrial Participation (NIP) Programme**

33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.

### **34 Prohibition of Restrictive practices**

34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).

34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
