

T2.2-01: Evaluation Schedule - Management & CV's of Key Personnel

The tender must be able to demonstrate that the project personnel have sufficient knowledge, experience and qualifications to provide the required services and submit the following documents as a minimum with the tender:

1. The experience of assigned key persons in relation to the scope of work will be evaluated from two different points of view, namely:
 - i. The education, training and skills of the assigned staff in the specific sector, field, subject, etc. which is directly linked to the Scope of Works. Proof of education and training must be attached to the C.V.
 - ii. Relevant experience - Experience on monitoring and maintenance of Local Area Networks
2. Comprehensive CV's should be attached to this schedule:

As a minimum each CV should address the following, but not limited to;

- i. Personal particulars
 - a. Name
 - b. Place (s) of tertiary education and dates associated therewith
 - c. Professional awards
 - ii. Qualifications (Product Certification, Cisco Certified Networking Associate (CCNA), CISCO Certified Networking Professional (CCNP), CISCO Certified InternetWorking Expert (CCIE) grades of membership of professional societies and professional registrations)
 - iii. Name of current employer and position in enterprise
 - iv. Overview of post graduate experience (year, organization and position)
 - v. Outline of recent assignments / experience that has a bearing on the Scope of Works
3. CV's for key persons proposed for identified posts shall have following minimum qualifications:
- Senior Network Technician/ Network Technician (Please attach proof of qualification)**
- I. Network+ (Plus) Certification
 - II. CISCO Certified Networking Associate (CCNA)
 - III. CISCO Certified Networking Professional (CCNP)
 - IV. CISCO Certified InternetWorking Expert (CCIE)
 - V. Relevant accredited training certificate in line with the scope of work
