## THE APPOINTMENT OF THE SERVICE PROVIDER FOR THE PRODUCTION AND INSTALLATION OF STATUE AND PLAQUE OF ARCHIBALD (ARCHIE) GUMEDE IN DURBAN, KWAZULU-NATAL

### 1. INTRODUCTION

The National Department of Sport, Arts and Culture (DSAC) is seeking to appoint a sculptor for the production and installation of a bronze statue that will be a realistic visual representation of Archibald (Archie) Gumede and plaque to be installed at the Frances Farewell Square (Church Walk), next to City Hall, eThekweni (Durban), KwaZulu-Natal. The Department will implement the project as a legacy project and working closely with key project stakeholders and the sculptor.

The purpose of this document is to outline project scope, deliverables and what is expected from the service provider in the project.

### 2. BACKGROUND

- 2.1 Mr. Archie Gumede was one of the founder members and leaders who was actively engaged in the struggle against oppression as most leaders were either in exile or imprisoned. Archie Gumede was elected one of the three Presidents of the new political movement called the United Democratic Front (UDF) in 1983.
- 2.2 The UDF filled a political leadership vacuum within the borders of the 1980s Apartheid South Africa while other political organisations were still banned. Under the leadership of Mr. Archie Gumede, UDF was instrumental as a political movement inside South Africa in bringing apartheid to its knees thus bringing democratic dispensation.
- 2.3 The objectives of the project:
  - 2.3.1 to transform the heritage landscape.
  - 2.3.2 to promote and preserve the legacy of Archie Gumede.





- 2.4 The **nine metre (9m) tall bronze statue including concrete plinth from the surface**, will be installed at the Frances Farewell Square, eThekweni, Church Walk, next to City Hall, which area is considered popular for hosting passers-by, pedestrians, and tourists who frequently use the space to rest and take pictures.

### 3. SCOPE AND EXTENT OF THE TENDER / TASK DIRECTIVE

- 3.1 The Department requires the services of a duly experienced and knowledgeable sculptor in undertaking the table below. Bidders should confirm that, they have read and understood the task description, they should indicate as such in the third column.

3.1.1	The service provider will be expected to produce and install a bronze statue that will be a realistic representation that honours the life and work of Mr. Archibald (Archie) Gumede with accompanying plaque.	
3.1.2	The expected deliverable is an installed bronze statue of Archie Gumede on a concrete plinth with a plaque containing a summarised inscription of Mr. Archie Gumede's contribution towards liberation and freedom.	
3.1.3	The production and installation of the statue should be completed <b>within eight (8) months period</b> after signing Service Level Agreement (SLA).	
3.1.4	Archie Gumede statue will be larger than life with the <b>size of six metres (6m) tall plus three metres (3m) tall concrete plinth from surface</b> . The total size of the statue together with concrete plinth will be <b>nine (9m) high, excluding foundation of the plinth</b> . The exact size of the underground depth of the concrete plinth foundation will be determined	





	by structural engineer and service provider. The total height of the artwork must perfectly correspond with the weight of the subject.	
3.1.5	The concrete plinth/pedestal must reflect designs of an <b>African aesthetic symbolism</b> against colonial narrative.	
3.1.6	The statue should capture both the actual likeness and personality of Archie Gumede. The sculptor/service provider must demonstrate skills in applying relevant portrait-making techniques to achieve this requirement. Elements such as gesture, pose, and general mannerisms of the portrayed subject must contribute towards the final likeness/appearance and personality of Archie Gumede. His high social standing as a struggle hero and statesman must also be astutely expressed in the final piece.	
3.1.7	Realist and romanticist elements must be successfully combined in the statue to add something that can enigmatically capture the viewer's imagination. Essential personality traits and mannerisms can be discovered through thorough preliminary research by the service provider. People who never had a privilege of personally interacting with Archie Gumede should be enabled to construct nostalgic feelings or 'memories' about his heroism, grace, steadfastness, etc. The personality of the subject must, by all possible means, be endowed with a strong 'presence'.	
3.1.8	The final piece must be visually convincing and aesthetically pleasing, complying strictly with all principles of scale and proportion. This can be achieved if the service provider accurately studies the basic personal characteristics of Archie Gumede including the distribution of his height and weight. Every part of the body should perfectly harmonize with the overall appearance of the whole statue.	







3.1.9	Elements of posture and gesture must be combined to construct a sense of compelling dignity and power marking Archie Gumede's personality. The statue must be in a <b>standing pose</b> .	
3.1.10	The statue must be <b>highly finished in bronze</b> , allowing the prestige of the material and the personality of the subject to enhance its visual impact.	
3.1.11	The main, final piece should be preceded by a maquette to be submitted and presented to the Project Steering Committee (PSC), strictly complying with all the above requirements. Its height must be 300mm. A two-dimensional drawing must include a north point and sightlines from various vantage points will be required. <b>NB:</b> This maquette is separate from the maquette submitted with bidding documentation.	
3.1.12	The service provider is required to construct corresponding landscape features around the artwork/piece, with clear ideas of the environmental context in a two-dimensional sketch.	
3.1.13	The <b>plaque</b> , also in <b>bronze</b> , must have a summarized <b>descriptive narration of 100 words</b> of who Mr. Archie Gumede was, including his key role in the formation of the UDF and his contribution as a politician after the demise of Apartheid. However, the <b>bold, visible, and easy-to-read text</b> must concisely capture the main description of the hero.	
3.1.14	The inscription on the above-mentioned plaque must be in <b>two official languages</b> predominantly spoken in KwaZulu-Natal <b>in this order, isiZulu and English</b> . The service provider must mount the plaque with descriptive inscription on the plinth after final approval by DSAC.	
3.1.15	The production phases/stages/process must be clearly stated and include, but not be limited to, <b>sculpture designs/sketches</b>	





	<b>development</b> ( <i>informed by extensive research</i> ), <b>moulding, casting, bronze making, transportation and installation.</b>	
3.1.16	The service provider will be required to present work in progress and obtain a go ahead from the PSC members before commencement of the next stage.	
3.1.17	The Department, in collaboration with the PSC and Gumede family, will approve a statue mould and plaque inscription before final product in bronze is completed.	
3.1.18	<p>All bid documents should be accompanied by the following:</p> <p><b>3.1.18.1 Graphic rendition of a drawn maquette and site model:</b></p> <p>Bidders will be required to submit a fully sketched presentation, artistic impression and graphic interpretation of the proposed Archie Gumede sculpture in a plinth/base that should be hand-drawn sketches or computerized two-dimensional (2D) versions showing front, back, side and aerial elevations with a synopsis explaining the concept. A two-dimensional drawing must include a north point and sightlines from various vantage points.</p> <p><b>3.1.18.2 Site Landscaping Design</b></p> <p>⇒ Bidders are required to design a cultural heritage landscape displaying liberation and transformation theme/symbolism.</p> <p><b>3.1.18.3 Inscription:</b></p> <p>⇒ Bidders are required to submit a draft inscription/summarized inscription of one hundred (100) words (<i>in English</i>) that will go onto the metal plaque.</p>	





3.1.19	The statue project implementation plan document must accommodate <b>all transportation logistics</b> of the mould from the studio to and from the foundry and to the site of installation including <b>transportation costs</b> .	
3.1.20	The service provider has an obligation, <i>after appointed</i> , to <b>appoint a registered professional civil structural engineer</b> to oversee the statue structural works based on their design, construction monitoring, and compliance certification of all the statue structural works undertaken by the appointed service provider/artist/sculptor. The <b>civil structural engineer</b> , appointed and paid by the service provider has the responsibility to undertake but not limited to the following activities, ( <i>scope of works will be agreed between engineer and service provider</i> ): <ul style="list-style-type: none"> <li>⇒ rationally design and specify suitable base/foundation.</li> <li>⇒ provide technical and detailed construction drawings.</li> </ul> <b>NB:</b> The above listed activities are crucial in ensuring the structural stability of the statue against mass, environmental factors, wind resistance and warranting the safety of the public.	
3.1.21	The Civil Structural Engineer must be a holder of a Civil Engineering Degree/BTech qualification, specializing in structural engineering design work and be professional registered with ECSA. The service provider must make allowance for conducting Geotechnical Investigations by a professional/registered soil laboratory.	
3.1.22	The service provider must <b>source two quotations</b> from the registered civil structural engineers clearly indicating cost estimates for rendering the required services. Quotations must be submitted together with bid documents with cost estimates reflected in the total cost breakdown of the project.	





3.1.23	The <b>payment of the civil structural engineer</b> for the services rendered will be <b>the responsibility of the service provider</b> and not the Department.	
3.1.24	Service provider must provide the Department with the <i>structural engineering <b>compliance</b> certificate</i> and <b>project completion certificate of the installed statue, plinth and plaque.</b>	
3.1.25	The service provider must <b>submit invoices accompanied by periodic reports of work completed</b> , incorporating photos, job opportunities created with details of people employed by the project. Details of employed people must include names, ID numbers, gender, age and area of work (skills transferred or developed), physical addresses and contacts. The reports must include the number of persons with disabilities who have been employed on the project should there be any.	
3.1.26	The service provider should make <b>budget provision for all necessary services required prior, during and after the production and installation of the statue and plaque.</b> These will include but not limited to:  3.1.26.1 Attending Project Steering Committee (PSC) meetings scheduled to be held in <b>Durban at least twice per quarter.</b>  3.1.26.2 Attending <b>foundry visits</b> with PSC for progress monitoring and approvals purposes. <b>Schedule of foundry visits</b> will be determined by the service provider in consultation with the PSC.  3.1.26.3 Insurance for transportation of the mould/statue from one place to another.  3.1.26.4 <b>Clearing and cleaning the site</b> before and after installation of the statue, plinth and plaque.

#### 4. EVALUATION STAGES

4.1 The bid evaluation process consists of several stages that are applicable as defined in the table below:

#### 4.1.2. Stage 2:

The Technical proposal will be evaluated out of 100 points with a threshold of 70 points. Bidders that score less than a minimum of 70 points will be disqualified. Bidders must score a minimum of 70 or more points to qualify for further evaluation on price and preference points.

#### 4.1.3. Stage 3:

Bids will then be evaluated in accordance with the prescripts of the Preferential Procurement Policy Framework Act (PPPFA) and the associated Preferential Procurement Regulations of 2022, which stipulate an 80/20 preference point system is applicable up to a rand value of R50 million (all applicable taxes included).

- The following criteria will be used as the criteria for appointment, apart from those laid down in the Preferential Procurement Regulations, 2022, pertaining to the Preferential Procurement Policy Framework Act 5 of 2000. Bidders are required to submit the following proof/documentation to claim points for specific goals:
  - a) **An affidavit by the person or person acting on behalf of an enterprise indicating the level of ownership in the enterprise by persons historically disadvantaged by unfair discrimination based on race, gender, age and disability (submit copies of IDs to support the Affidavit) or**
  - b) **Ownership Certificate issued by the Companies and Intellectual Property Commission (CIPC)**

## 5. EVALUATION PROCESS

- 5.1 The 80/20 preference point system in terms of the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000) shall apply. The lowest acceptable bid will score 80 points for price and 20 points will be awarded for specific goals as stipulated on SBD 6.1. of this bid.
- 5.2 Prospective bidders will have to score at least 70 out of 100 points allocated for functionality before the company's proposal will be considered for pricing.

## 6. BID REQUIREMENTS

### General requirements

- 6.1. The following is required of bidders and should be submitted to the department as part of the bid submission:
- 6.1.1 Company profile.
- 6.1.2 All Bidders must be registered on the National Treasury Central Supplier Database (CSD) and must attach a copy of the most recent report to the tender document.
- 6.1.3 The tax status on CSD must be compliant, as Department is unable to award a contract to a company whose tax affairs are not in order as determined by SARS. A







recommended bidder whose tax matters have expired, or compliance status is invalid will be notified in writing of their non-compliance status and the bidder must be requested to submit written proof from SARS of their tax compliant status or proof that they have made an arrangement to meet their outstanding tax obligations within 7 working days. The bidder should thereafter provide the Department with proof of their tax compliant status which should be verified via CSD.

- 6.1.4 Original Company Resolution or Letter of authority or Letter of appointment authorizing the signatory of the Entity to sign the contract with the Department.
- 6.1.5 Valid contact details including e-mail address.
- 6.1.6 Certified ID copies of all Directors.
- 6.1.7 Reference letters must be provided, as well as an indication of experience with similar projects.
- 6.1.8 Companies, who registered for VAT, should include VAT on their costing.
- 6.1.9 Any other details that may be relevant in respect of the tender evaluation criteria.

## **6.2 Technical Requirements**

### **Bidders to submit a detailed proposal including.**

- 6.2.1 Project Implementation plan.
- 6.2.2 Detailed Cost breakdown
- 6.2.3 Capacity and experience.
- 6.2.4 Number and level/ranks of team member/s to be involved in sculpturing.
- 6.2.5 CVs of all involved in sculpturing (including but not limited to qualifications, knowledge, experience and level of expertise and/or current designation).







## 7. EVALUATION CRITERIA

All bids duly lodged will be evaluated by a panel first on functionality then price. For purposes of comparison and to ensure meaningful evaluation, bidders are requested to furnish detailed information in substantiation of compliance to each of the evaluation criteria mentioned below.

## 8. CONFIDENTIALITY

- 8.1 No information or documentation may be used for any other purpose other than providing for a tender proposal to the Department, and no copies of any document may be made, except with prior written approval from the Department.
- 8.2 The successful bidders and staff will be required to sign a non-disclosure agreement.

## 9. INTELLECTUAL PROPERTY AND OWNERSHIP

- 9.1 Ownership and copyright of all documentation developed during the period of the contract will be vested in the Department of Sport, Arts and Culture.
- 9.2 All intellectual property rights relating to any work produced by the service provider in relation to the performance of this contract shall belong to the Department and may not be used for any other purpose by the service provider. The service provider shall give the Department all assistance in protecting such intellectual property rights. All material, in paper, electronic or any recorded format produced by the service provider in the performance of this contract shall remain the property of the Department of Sport, Arts and Culture and must be handed over to the Department on termination of the contract.
- 9.3 All service providers undertake not to infringe the intellectual property of third parties. Should any action or claim be instituted against the Department emanating from an infringement of





intellectual property or an alleged infringement of intellectual property, the service providers hereby indemnify the Department against such claims or actions as well as all costs (including legal costs on an attorney and client scale).

## 10. **CONTRACTUAL ARRANGEMENT**

The service provider is required to enter into a Service Level Agreement (SLA) with the Department of Sport, Arts and Culture to perform all functions as set out in the project Specification or Terms of Reference and National Treasury General Conditions of Contract of 2010. The contract duration will be **eight (8) months** from the date of concluding the SLA. The exact contract duration will be agreed upon during signing of the SLA. The service provider should attend a meeting at the DSAC within a week of his/her appointment and should avail himself/herself for progress meetings as per the Department's request.

## 11. **FINANCIAL IMPLICATIONS**

- 11.1 The project budget has been allocated for the statue production and will be sourced from Heritage Asset: Programme 2 capital Works budget as per the UAMP ENE 2023 allocation.
- 11.2 No service will be provided to the Department before an official order has been issued to the service provider.
- 11.3 The Department will not make an upfront payment to the service provider.
- 11.4 Tranche payments schedule will be discussed and agreed upon during the process of signing SLA based on agreed milestones completed and signed off.
- 11.5 Payments will be done according to the schedule and requirements as per the provision of the signed Service Level Agreement (SLA).

## 12. **CLIENT BASE**

The Department of Sport, Arts and Culture (DSAC) reserves the right to contact references during the evaluation and adjudication process to obtain information.

**NOTES**

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

## **General Conditions of Contract**

### **1. Definitions**

1. The following terms shall be interpreted as indicated:
  - 1.1 “Closing time” means the date and hour specified in the bidding documents for the receipt of bids.
  - 1.2 “Contract” means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
  - 1.3 “Contract price” means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
  - 1.4 “Corrupt practice” means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
  - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
  - 1.6 “Country of origin” means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
  - 1.7 “Day” means calendar day.
  - 1.8 “Delivery” means delivery in compliance of the conditions of the contract or order.
  - 1.9 “Delivery ex stock” means immediate delivery directly from stock actually on hand.
  - 1.10 “Delivery into consignees store or to his site” means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
  - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the

RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such

obligations of the supplier covered under the contract.

- 1.25 “Written” or “in writing” means handwritten in ink or any form of electronic or mechanical writing.

## **2. Application**

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

## **3. General**

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from [www.treasury.gov.za](http://www.treasury.gov.za)

## **4. Standards**

- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

## **5. Use of contract documents and information; inspection.**

- 5.1 The supplier shall not, without the purchaser’s prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser’s prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier’s performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier’s records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

## **6. Patent rights**

- 6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

**7. Performance security**

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
  - (b) a cashier's or certified cheque
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

**8. Inspections, tests and analyses**

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract supplies may on or after delivery be inspected, tested or

analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.

- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

## **9. Packing**

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

## **10. Delivery and documents**

- 10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2 Documents to be submitted by the supplier are specified in SCC.

## **11. Insurance**

- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

## **12. Transportation**

- 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

## **13. Incidental services**

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
  - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
  - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;

- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

#### **14. Spare parts**

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
  - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
  - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

#### **15. Warranty**

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take



such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

**16. Payment**

- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated in SCC.

**17. Prices**

- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.

**18. Contract amendments**

- 18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.

**19. Assignment**

- 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

**20. Subcontracts**

- 20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

**21. Delays in the supplier's performance**

- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the

supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.

21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

## **22. Penalties**

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

## **23. Termination for default**

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any

person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (i) the name and address of the supplier and / or person restricted by the purchaser;
- (ii) the date of commencement of the restriction
- (iii) the period of restriction; and
- (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

#### **24. Anti-dumping and countervailing duties and rights**

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which

may be due to him

**25. Force Majeure**

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

**26. Termination for insolvency**

- 26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

**27. Settlement of Disputes**

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
  - (b) the purchaser shall pay the supplier any monies due the supplier.

**28. Limitation of liability**

- 28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

	(b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
<b>29. Governing language</b>	29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
<b>30. Applicable law</b>	30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
<b>31. Notices</b>	<p>31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice</p> <p>31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.</p>
<b>32. Taxes and duties</b>	<p>32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.</p> <p>32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.</p> <p>32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.</p>
<b>33. National Industrial Participation Programme (NIP)</b>	33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.
<b>34 Prohibition of Restrictive practices</b>	<p>34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).</p> <p>34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.</p>

- 34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
