The Board training is to be conducted online accommodating a total of thirteen(13) participants in November 2025.

The training will span a maximum of two days, and the service provider is expected to deliver the program details two weeks prior to the training session.

The training program should prioritize the delivery of professional services, encompassing, but not limited to, the following:

- A. One Day of Masterclass training aimed at improving proficiency of experienced board members and newer board members. This training must include:
  - Changes to the governance and regulators landscape impacting on boards, including moving from King IV to King V
  - Practical case studies as well as real or simulated business case scenarios and training to improve effectiveness of chairpersons, sub-committee chairpersons, board members and executive directors.
- B. One day of board training aimed at strengthening knowledge of board members in the following areas:
  - Strategic Leadership: Strategic leadership responsibilities of the board;
     Regulatory, King IV & King V and other governance developments;
     Stakeholder responsibilities and management; and financial efficiency, long-term perspective, sustainable growth.
  - **Governance**: Fiduciary responsibilities of the board, Ethical responsibilities of the board, financial responsibilities of the board (including IFRS 9 and internal audit function) and Technological responsibilities of the Board.
  - Risk Governance: Latest developments and thinking relating to risk assessment, management, and mitigation; and Risk management, including reputational risk, market risk, credit risk, liquidity risk, interest rate risk, operational risk, and compliance risk).

- 1.1 The following preference point systems are applicable to invitations to tender:

### 2. **DEFINITIONS**

- (e) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (f) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000); and

# 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
