T1.1 TENDER NOTICE AND INVITATION TO TENDER (Incorporating SBD1)

The South African National Roads Agency SOC Limited (SANRAL) invites tenders for the provision of Ad-hoc Structural and Drainage Consulting Engineering and Supervision Services for the Northern Region. The services envisaged under this appointment will be on an *as-needed basis* and relates to, but is not limited to, preventative services, repair/rehabilitation services, capacity improvement services, emergency/urgent services, inspection services and assessment services for all types of structures on the National Road Network within the provincial areas of Gauteng, Mpumalanga, Limpopo and North West. The duration of the appointment will be for 5 years, however SANRAL reserves the right to cancel the contract at any time after 3 years of the contract duration has elapsed.

Only tenderers who are registered on the National Treasury Central Supplier Database and meet the minimum requirements for the key persons as stipulated in Clause C.2.1 at the tender closing date are eligible to tender.

Joint Ventures (JV) will be allowed on condition that one JV partner is a Targeted Enterprise. The JV partner will, however, not contribute to sub-contract target for Targeted Enterprises.
