- COMPANY EXPERIENCE** – will be evaluated based on the following:
  - Proof of experience must clearly show the detailed relevant scope of work, not contract or project title, contract or order number and the duration of the works to be clearly visible.
  - In case where it's different orders, a very clear detailed list to be on top of the proof with all the information as in the above bullet point.
  - Documents of companies that issued contract or order number should bear the company logo and letter head.
- TECHNICAL APPROACH** – will be evaluated based on the following:
  - ONLY a very clear letter of intent agreement with a registered service provider and/or registered CLASS A LANDFILL SITE will be considered.
  - Method statement must be for this service ONLY and to be very clear and detailed, (upholding safety of paramount importance people, machinery and falling objects).
- PERSONNEL EXPERIENCE** – all police certified copy of certificates & I.D's (no older than 03 months) will be evaluated based on the following:
  - Very clear and detailed CV's with relevant experience otherwise no evaluations will be done without CV's.
  - Valid and certified (no older than 03 months) certificates to be attached.
  - All CV's to be **CLEARLY NUMBERED & LABELLED AND THE ACCOMPANYING CERTIFICATES TO FOLLOW** not the other way round.
