# PART A – THE TENDER

## INTRODUCTION TO THE NRF

The National Research Foundation (“NRF”) is a Schedule 3A statutory entity established in terms of the Public Finance Management Act, No. 1 of 1999, as well as the National Research Foundation Act, No. 19 of 2018, as amended. The National Research Foundation will contract with the appointed bidder, through its business unit, the South African Radio Astronomy Observatory (SARAO), described below. Visit the NRF website (<https://www.nrf.ac.za>) for more information.

## BACKGROUND TO SARAO AND THE MEERKAT TELESCOPE

SARAO is a business unit of the NRF, incorporating South Africa’s radio astronomy instruments and programmes such as the MeerKAT and KAT-7 telescopes in the Karoo, Northern Cape, the Hartebeesthoek Radio Astronomy Observatory (HartRAO) in Gauteng, the African Very Long Baseline Interferometry (AVN) programme in nine African countries as well as the associated human capital development and commercialisation endeavours. The MeerKAT Telescope, located in the Karoo region of South Africa, is a precursor to the larger SKA-Mid (Square Kilometre Array Mid-frequency) telescope. SKA-Mid will incorporate MeerKAT's 64 dishes along with 133 new 15-meter dishes, forming an array spanning up to 150 km. The site is in a designated radio-protected zone in the Northern Cape, near the town of Carnarvon. Location - Northern Cape Province, South Africa (30 degrees South, 21 degrees East).

## BACKGROUND TO THE SKA OBSERVATORY

The international Square Kilometre Astronomy Observatory (‘SKA Observatory’ or ‘SKAO’) is an intergovernmental treaty organisation of which South Africa is a Founding Member. The SKAO is responsible for delivery of the SKA project. # OVERVIEW OF THE TENDER

## Background to the G20 Summit 2025

The Group of Twenty (G20) is the premier forum for international economic cooperation, comprising 19 countries and the European Union. Together, G20 members represent over 80% of global GDP, 75% of international trade, and two-thirds of the world's population. The G20 plays a central role in shaping global economic policy and addressing pressing global challenges, from climate change to health and digital transformation. South Africa, as the only permanent African member of the G20, plays a vital role in representing the continent's interests and advocating for inclusive global growth, sustainable development, and strengthened cooperation in science, technology, and innovation (STI).

The G20 Summit for 2025 is being hosted by South Africa, as the current President of the G20. This presents South Africa with a unique platform to shape the global agenda and highlight African perspectives on development, innovation, and cooperation. South Africa's G20 Presidency places a strong emphasis on -

- Inclusive and sustainable development;
- Global science and innovation partnership;
- Just energy transitions; and
- Digital economy and skills development.

## Event Overview

As part of this global engagement, South Africa is hosting several high-level meetings, including the **G20 Science, Technology, and Innovation Ministers' Meeting**. This includes a **ministerial visit to the SKA-Mid / MeerKAT site in the Karoo** (the 'event'), to showcase the country's leadership in large-scale, globally relevant scientific infrastructure, and its commitment to international collaboration in astronomy, innovation, and socio-economic development. Showcasing the SKA telescope is pivotal to this effort. The SKA telescope, co-hosted by South Africa and Australia, represents one of the most ambitious global scientific endeavours of the 21<sup>st</sup> century and aligns directly with the G20's vision for transformative, collaborative research.

The Department of Science, Technology and Innovation (DSTI), together with the South African Radio Astronomy Observatory (SARAO) and the SKAO, will host the G20 Science, Technology, and Innovation Ministers' meeting at the SKA-Mid / MeerKAT site in the Karoo. This exclusive event is designed for high-level delegates and strategic stakeholders coming

from approximately 30 countries.

## Purpose of the G20 Event

The event will serve to -

- **Showcase global scientific ambition:** Demonstrate the groundbreaking work of the SKAO and its precursors (e.g. MeerKAT) in advancing astronomy and global scientific frontiers.
- **Inspire with scientific discovery:** Present the exceptional science already delivered by MeerKAT and future discoveries anticipated through the SKA-Mid and related infrastructure.
- **Highlight science diplomacy and innovation:** Emphasise South Africa's and SKAO's pivotal role in advancing international collaboration, technological innovation, and societal development through science.
- **Celebrate South Africa's contribution:** Recognise South Africa's integral role in designing, developing, and hosting cutting-edge research infrastructure.
- **Promote science investment:** Position South Africa as a premier global destination for science, technology, and innovation investment.
- **Demonstrate socio-economic impact:** Illustrate how large-scale research infrastructure can drive real, measurable socio-economic development in local communities.
- **Emphasise how some of the world's largest economies' investments in radio astronomy** are contributing to sustainable development and addressing key societal challenges.
- Celebrate and profile **South African excellence** in science, engineering, and innovation.
- **Reinvigorate support** among existing SKAO member countries and partners.
- **Attract new members** to the SKAO international partnership.
- Position the SKAO as a leading model of **science diplomacy and multilateral collaboration**.
- Strengthen and amplify the **global visibility** of both South Africa and the SKAO.
- Create an inspiring and memorable experience aligned with the SKAO and SARAO's values and future vision.



# The Exhibition

## Conceptual Direction

The exhibition should be framed by the powerful metaphor of **“South Africa’s Long Walk to Freedom through Science”** — a narrative journey that traces the country’s transformation into a global leader in scientific and technological excellence.

The exhibition should be technologically innovative, while featuring the primary driver of both SARAO and the SKAO, which is delivering world-class science. MeerKAT has already yielded fantastic scientific results and stunning images that can be used to impress the audience and explain the discoveries the telescope has enabled in its first years of operation. Other facilities around the world named SKA pathfinders also have great scientific results on their tally, which can be featured here. They are particularly relevant as VVIPs will come from the countries that own these facilities, and this should serve as a great reminder of those countries’ vibrant radio astronomy community and the fact that they host facilities which are paving the way for some more exciting science possibilities when the SKA telescopes come online in the next few years. In addition to the highlights from the Pathfinder facilities, the exhibition should also highlight the key science drivers for the MeerKAT, the SKAO, and its two telescopes (more information available at: <https://www.skao.int/en/science-users/science-working-groups>), which represent the motivation for funding the Observatory.

The exhibition should also prominently feature the people and community partnerships that are central to SARAO’s and the SKAO’s mission, in line with both organisations’ commitment to deliver on the UN Sustainable Development Goals (SDGs). These include:

- **Meerkat National Park and conservation/biodiversity efforts**
- **SANPARKS** and the protection of the Meerkat National Park

## Cultural Investments

- **Astro-tourism guides** and ambassadors.
- **Carnarvon Cultural Association** - Rieldancers

## Investments in Local Communities surrounding the Telescope

- **Early childhood development (ECD)**
- **SARAO Robotics programme**
- **SARAO HCD Program** - Local schools and youth science initiatives.

- Community Development Program - (Siyafunda Computer Center, Swartkop Multipurpose Centre, and Sports & Recreational Activities)
- **DARA programme** (<https://www.dara-project.org/>)
- **Artisans**
- **Local crafters and small enterprises** are supported through SARAO's outreach efforts.
- **Cosmic Echoes Indigenous art astronomy exhibition** (<https://www.skao.int/en/cosmic-echoes>)

Through compelling storytelling, multimedia elements, interactive features, and community voices, the exhibition should capture the spirit of human collaboration, shared discovery, and the transformative power of science.

The exhibition should also feature actual SARAO and the SKAO technical instruments, such as an SKA-Low antenna, receivers, compressors, power panels, and sub-system components, currently staged inside the telescope shed on the SKA MeerKAT site (this means we don't expect the exhibition company to source this hardware). Some of this hardware is being manufactured overseas and will be used as concrete examples demonstrating how those countries contribute to the SKAO and benefit from their involvement in the Observatory through industry involvement, innovation, contracts, job creation, et cetera. The hardware should be:

- Visibly integrated into the exhibition experience.
- Accompanied by clear, visually engaging signage or interactive explanations.
- Lit and positioned appropriately to enhance rather than detract from the space.
- Optionally staged with guided mini-stations or short talks during the visit. This can include SKA Low antennas, Receivers, Aspects of precursors, et cetera.

Builders should plan for these components as semi-fixed elements that cannot be removed. The design must flow around and incorporate them as immersive features. An idea could be to display a world map highlighting the SKAO countries (refer to p. 13 [here](#)) and include key information (in bullet points) related to each country, featuring key contributions to the SKAO, contract value, et cetera. The object is to appeal to that audience, giving them a bird's eye view of what their country is contributing to the global endeavour and what they have in return.

Lastly, the exhibition should touch on space sustainability and more specifically, the role of the SKAO and SARAO in the space sustainability agenda; SARAO through the South African government, and the SKAO through the Observatory's co-hosting of the International Astronomical Union Centre for the Protection of the Dark and Quiet Sky (IAU CPS), and its status as Permanent Observer of the Committee on the Peaceful Uses of Outer Space (COPUOS) and Sector Member of the UN International Telecommunications Union (ITU). This could be achieved through an informative banner aimed at raising awareness about the issue of a Dark and Quiet Sky, serving as a talking point for engaging with the audience.

## **Scope of Work - Exhibition for G20 Science, Technology, and Innovation Ministers' Meeting**

SARAO invites bid proposals from experienced service providers, to design, develop, and construct a compelling and immersive exhibition that will support and fulfil the event objectives as described above. The event will be hosted at the SKA MeerKAT site. The SKA MeerKAT site is located in the Northern Cape province of South Africa, approximately 90 km outside the town of Carnarvon. GPS Coordinates for the exhibit location - 30°42'48"S 21°26'35"E.

The appointed bidder will be expected to deliver:

- A detailed creative concept proposal, including layout designs, mock-ups, and narrative flow.
- Final exhibition content, including text, graphics, multimedia assets, and supporting documentation.
- All fabricated elements of the exhibition are ready for installation at the SKA-Mid/MeerKAT site.
- On-site installation and technical support must be provided during the setup phase of the event.
- A handover pack, including maintenance guidelines, source files, and content usage rights.
- Aspects of the Exhibit should be reusable in future events.
- A modular design, as far as possible, will be optimal.
- Building and placement of digital screens/ interactive aspects.

The exhibition should:

- Utilise the available exhibition space effectively. The total exhibition space is a minimum of 17 metres by 18 metres by 13 metres high. The exhibit needs to use this space to

profile the above-mentioned narrative optimally.

- Bring to life, the story of one of the world's most ambitious scientific endeavours.
- Optimally utilise the space available.
- Visually and experientially engage guests with the scientific achievements and future promise of the SKAO and MeerKAT. This will be linked to MeerKAT science and the Science objectives of the SKA observatory. This includes the nature of gravity, the formation of the first stars and galaxies, the evolution of galaxies, the search for extraterrestrial life, and the nature of dark energy.
- Showcase the SKAO as a model of international cooperation, scientific diplomacy, and community engagement through 'real-life' examples, demos, hardware, et cetera.
- Underscore South Africa's strategic role as a global partner in science and innovation.
- Inspire confidence in South Africa's ability to deliver high-impact, globally relevant science infrastructure.
- Celebrate the real-world socio-economic benefits of astronomy-led development.
- The exhibit will be visited by between 300 and 400 individuals over 3 days .
- Note -
  - Stock images, photography and site material will be made available for content development.
  - There will be 220 volt outlets available, as well as 3 phase power. There is no reception or data network available on the site.
  - All health and safety protocols on site need to be adhered to. The successful bidder will be taken through an induction process.

- Detailed development of the Exhibit
- Development of Electronic, visual and conceptual aspects of the Exhibit
- Construction/manufacturing of the Exhibit
- Erection of the Exhibit on the SKA/MeerKAT site
- Exhibit handover and training of SKA/SARAO staff
- Technical support during the Event/audio visual/electronic/movable parts
- Dismantling and removal of non-reusable parts of the exhibit

Thus, the total amount that can be claimed by the Purchaser from the Supplier for the duration of this Agreement is equal to, in aggregate, the total contract price under this Agreement;
28.1.3	under no circumstances whatsoever shall the Supplier be liable for any indirect, special, incidental, punitive or consequential Loss (from whatsoever cause arising and whether delictual or contractual), under or in connection with this Agreement;
28.1.4	where the Purchaser or the Purchaser's Personnel (including Third Party Suppliers or Contractors) is reasonably suspected of having been involved, in collusion or otherwise, in any claim, the Supplier's maximum liability shall not exceed fifty percent (50%) of the total amount claimed;
28.1.5	the Supplier and the Supplier's Personnel shall not be liable to the Purchaser or the Purchaser's Personnel in any circumstances or to any extent whatsoever in respect of any Loss unless written notice of a claim is received by the Supplier following the discovery by the Purchaser or the Purchaser's Personnel of the Loss alleged to give rise to any such claim;

35.1	The Agreement between the Parties shall inter alia comprise of the following documents –

36.1	The Supplier's personnel performing work at the Purchaser's Premises as part of this Agreement are required to undergo safety induction.
36.2	Over and above the obligations required by the Occupational Health and Safety Act, No. 85 of 1993 (OHS Act) and its Regulations, ('the Act'), the Supplier will be required to comply with all relevant health and safety written instructions given to them by the Purchaser's site safety Personnel, where relevant. Personal protection equipment, including closed safety shoes, hard hats, height safety equipment, and high visibility vests must be worn at all times while on the work site. The Supplier's Personnel are to obey all reasonable instructions, including signage, related to restricted access and speed limits on the Purchaser Premises.
36.3	The Supplier, once signing the Agreement, is responsible for itself, its employees, and all persons affected by its operations in terms of the Act and regulations promulgated in terms thereof. The Supplier must perform all work and use equipment on site in compliance with the provisions of the Act.
36.4	Where applicable, the Supplier must submit its Letter of Good Standing in terms of the COID Act to the Purchaser, and must ensure that it remains valid for the Initial Period.
36.5	Where applicable, the Supplier must maintain a health and safety plan complying with the requirements of the Act at the Purchaser Premises during the period that the Services are rendered at the Purchaser's Premises.
36.6	The Purchaser will manage the Supplier in its capacity to execute this Agreement to meet the provisions of the Act and the Regulations promulgated in terms thereof. The Supplier shall accept liability for any contraventions of the Act. Each member of the Supplier's team (including Personnel), must submit a signed indemnity form prior to entering the Purchaser's Premises, which must be kept in the Supplier's health and safety file.



## GENERAL CONDITIONS OF CONTRACT (GCC)

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

The NRF cannot amend the National Treasury’s General Conditions of Contract (GCC). The NRF compiles separate Special Conditions of Contract (SCC) relevant to this bid where applicable supplementing the General Conditions of Contract. Where there is conflict, the provisions of the Special Conditions of Contract shall prevail.

<b>GCC 1</b>	<b>Definitions – The following terms shall be interpreted as indicated:</b>
1.1	“Closing time” means the date and hour specified in the bidding documents for the receipt of bids.
1.2	“Contract” means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
1.3	“Contract price” means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
1.4	“Corrupt practice” means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
1.5	“Countervailing duties” are imposed in cases where an enterprise abroad is subsidised by its government and encouraged to market its products internationally.
1.6	“Country of origin” means the place where the goods were mined, grown, or produced, or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components
1.7	“Day” means calendar day.
1.8	“Delivery” means delivery in compliance with the conditions of the contract or order.
1.9	“Delivery ex stock” means immediate delivery directly from stock actually on hand.
1.10	“Delivery into consignees store or to his site” means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
1.11	“Dumping” occurs when a private enterprise abroad markets its goods on its own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
1.12	“Force majeure” means an event beyond the control of the supplier and not involving the supplier’s fault or negligence and not foreseeable. Such events may include, but are not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
1.13	“Fraudulent practice” means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
1.14	“GCC” means the General Conditions of Contract.
1.15	“Goods” means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
1.16	“Imported content” means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
1.17	“Local content” means that portion of the bidding price, which is not included in the imported content provided that local manufacture does take place.
1.18	“Manufacture” means the production of products in a factory using labour, materials, components, and machinery and includes other related value-adding activities.
1.19	“Order” means an official written order issued for the supply of goods or works or the rendering of a service.

1.20	"Project site", where applicable, means the place indicated in bidding documents.
1.21	"Purchaser" means the organization purchasing the goods.
1.22	"Republic" means the Republic of South Africa.
1.23	"SCC" means the Special Conditions of Contract.
1.24	"Services" means those functional services ancillaries to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
1.25	"Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.
<b>GCC2</b>	<b>Application</b>
2.1	These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
2.2	Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
2.3	Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.
<b>GCC 3</b>	<b>General</b>
3.1	Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
3.2	With certain exceptions (National Treasury's eTender website), invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from <a href="http://www.treasury.gov.za">www.treasury.gov.za</a>
<b>GCC 4</b>	<b>Standards</b>
4.1	The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
<b>GCC 5</b>	<b>Use of contract documents and information</b>
5.1	The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure made to any such employed person is in confidence and shall extend only as far as may be necessary for purposes of such performance.
5.2	The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
5.3	Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
5.4	The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and consents to have the documents audited by auditors appointed by the purchaser, if so required by the purchaser.
<b>GCC6</b>	<b>Patent rights</b>
6.1	The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
<b>GCC7</b>	<b>Performance security</b>
7.1	Within thirty days (30) of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
7.2	The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
7.3	The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
7.3.1	bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
7.3.2	cashier's or certified cheque.

7.4	The performance security will be discharged by the purchaser and returned to the supplier within thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.
<b>GCC8</b>	<b>Inspections, tests and analyses</b>
8.1	All pre-bidding testing will be for the account of the bidder.
8.2	If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the purchaser or an organization acting on behalf of the purchaser.
8.3	If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period, it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
8.4	If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
8.5	Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the supplier shall defray the cost in connection with these inspections, tests, or analyses.
8.6	Supplies and services referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
8.7	Any contract supplies may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies are held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies, which do comply with the requirements of the contract. Failing such removal, the rejected supplies shall be returned at the supplier's cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.
8.8	The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract because of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.
<b>GCC9</b>	<b>Packing</b>
9.1	The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt, and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
9.2	The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.
<b>GCC10</b>	<b>Delivery and Documentation</b>
10.1	Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
10.2	Documents submitted by the supplier specified in SCC.
<b>GCC11</b>	<b>Insurance</b>
11.1	The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.
<b>GCC12</b>	<b>Transportation</b>
12.1	Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.
<b>GCC13</b>	<b>Incidental services</b>
13.1	The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
13.1.1	Performance or supervision of on-site assembly and/or commissioning of the supplied goods;
13.1.2	Furnishing of tools required for assembly and/or maintenance of the supplied goods;

13.1.3	Furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
13.1.4	Performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
13.1.5	Training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
13.2	Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.
<b>GCC14</b>	<b>Spare parts</b>
14.1	As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
14.1.1	Such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
14.1.2	In the event of termination of production of the spare parts:
14.1.2.1	Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and

<b>GCC15</b>	<b>Warranty</b>

- ii) The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;
- iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 4.2, the contractor may be required to furnish documentary proof to the satisfaction of the organ of state that the claims are correct;
- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
  - (a) disqualify the person from the tendering process;
  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution, if deemed necessary.
