## 1. PURPOSE

The purpose of this Request for Quotation (RFQ) is to invite suitably qualified and experienced service provider to submit quotations for the provision of controlled document management, manual authoring, compilation, standardisation, and regulatory liaison services in support of South African National Parks (SANParks) Air Services' aviation operations.

The services are required to ensure that SANParks Air Services, manuals of procedure and maintenance-related manuals are developed, maintained and presented in accordance with:

- SANParks operational and security requirement; and
- The applicable regulatory requirements of the South African Civil Aviation Authority (SACAA).

## 2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

## 3. SCOPE OF WORK

SANParks Air Services conducts aviation operations within a regulated environment requiring formally approved, controlled and current manuals. These manuals must accurately reflect operations, maintenance activities, safety and security arrangements, and quality systems, and must remain aligned with evolving regulatory requirements.

SANParks Air Services therefore seeks to appoint a specialist service provider with demonstrated capability in aviation manual development, document control, regulatory compliance and professional document presentation.

### 3.1. General Scope

SANParks Air Services operates within a high-consequence regulatory environment. The appointed service provider will be responsible for the lifecycle management of aviation manuals, including authoring, technical editing, regulatory alignment, and digital version control. This includes ensuring that all "Controlled Documents" are audit-ready and compliant with SACAA Part 127 (Helicopter).

### 3.2. Operations & Safety Manuals (Manuals of Procedure (MOPs))

Manuals shall be developed and maintained to reflect current SANParks operational profiles, including but not limited to:

- **Operations Manual (OM):** Parts A (General), B (Aircraft Operating Manual), C (Route/Area), and D (Training).
- **Safety Management System (SMS) Manual:** To include the Emergency Response Plan (ERP) and Risk Management frameworks.
- **Quality Management System (QMS) / Quality Manual:** In line with ISO 9001:2015 or aviation-specific quality standards.
- **Airport/Airstrip Security Programme (ASP):** Specific to SANParks runways and helipads.
- **Dangerous Goods Manual (DGM):** In compliance with IATA/ICAO technical instructions.

### 3.3. Aviation Maintenance Manuals & Airworthiness Documentations

The scope extends to all technical manuals required for Continued Airworthiness, specifically:

- **Maintenance Control Manual (MCM):** Detailed procedures for maintenance oversight.
- **Minimum Equipment List (MEL):** Derived from the Master Minimum Equipment List (MMEL) for the H125 fleet.

- **Approved Maintenance Programme (AMP):** Tailored to the H125/AS350 B3 utilization rate.
- **Safety & Emergency Equipment Manual (SEPM):** For onboard equipment and surveillance tech.

### 3.4. Key Functional Requirements

The service provider must demonstrate the ability to deliver the following three-fold capability:

#### 3.4.1. Regulatory & Technical Compliance

- **Regulatory Mapping:** Ability to map manual content against SA-CARs and SA-CATS to ensure 100% compliance during SACAA base audits.
- **Technical Interpretation:** Interpretation of Aeronautical Information Circulars (AICs) and NOTAMs to assess the impact on current SOPs.
- **Audit Support:** Representation during SACAA inspections to defend manual structures and address "Findings" or "Observations" related to documentation.

#### 3.4.2. Editorial & Structural Consistency

- **Standardization:** Implementation of a "Single Source" terminology database (e.g., ensuring "Pilot-in-Command" is used consistently rather than "Captain" or "PIC").
- **Cross-Reference Integrity:** Ensuring that an amendment in the Operations Manual automatically triggers a review of the SMS or Training Manual where those procedures overlap.
- **Collaborative Authoring:** Facilitating workshops with SANParks Post-Holders (e.g., Responsible Person: Flight Operations) to capture actual field practices.

#### 3.4.3. Digital Control & Presentation Capability

- **Digital Distribution:** While MS Word is the base, the provider must demonstrate the ability to output hyperlinked, indexed PDFs suitable for use in Electronic Flight Bags (EFB).
- **Master Document Register:** Maintenance of a live "Document Status" dashboard showing revision dates, next review dates, and SACAA approval status.
- **Revision Management:** Execution of "Vertical Bars" (Revision Markers) in margins to clearly indicate changed text to pilots and auditors.

### 3.5. Service Delivery Instructions

The service provider may conduct most of the authoring and document control activities remotely. However, the bidder must demonstrate the capacity to attend on-site workshops at SANParks Air Services' base of operations as and when required for operational alignment and audit support. Bidders must include all associated travel costs in their financial proposal as per the specified pricing schedule.

**Note: Kindly note that conservation fees will be applicable upon entry into the park.**

## 4. DOCUMENT CONTROL AND MAINTENANCE

The service provider will be required to:

- **Version Control:** Implement a robust version control system that includes unique revision numbers, "Vertical Revision Bars" to highlight changes, and effective dates on every page.
- **Digital Distribution:** Provide the capability to output manuals in indexed, hyperlinked, and searchable PDF formats optimized for Electronic Flight Bags (EFB).
- **Audit Trail:** Maintain a Master Record of Revisions (MRR) and an amendment history log that is "Audit-Ready" for SACAA base inspections.
- **Operational Alignment:** Conduct periodic "Ground-Truth" reviews with SANParks Post-Holders to ensure that documented procedures match actual field practices (e.g., game capture and sling-load ops).

## 5. REGULATORY LIAISON

The appointed service provider shall be authorized to:

- **Technical Representation:** Act as the technical liaison with the SACAA for the submission of Form CA-127/135 (and relevant parts).
- **Findings Resolution:** Assist in drafting Corrective Action Plans (CAPs) to address documentation-related "Findings" or "Observations" issued by SACAA inspectors.
- **Advisory Role:** Monitor and alert SANParks to new Aeronautical Information Circulars (AICs), NOTAMs, and Legislative Amendments that necessitate manual updates.
- **Note on Authority:** While the provider facilitates the process, all submissions must be signed off by the relevant SANParks Accountable Manager or delegated Post-Holder.

## 5. DELIVERABLES

Deliverables shall include, but are not limited to:

- **Submission Packages:** Complete "Ready-for-Submission" packs, including cross-reference matrices against the relevant SA-CATS.
- **Electronic Master Copies:** Unlocked source files (e.g., MS Word/XML) and locked Controlled Master Copies (PDF).
- **Amendment Summaries & Change Logs:** A comprehensive "Highlight of Changes" document for every revision to facilitate pilot/crew briefings.
- **Compliance Dashboard:** A monthly status report indicating the current revision status of the entire SANParks Technical Library.

## 6. FUNCTIONALITY / TECHNICAL REQUIREMENTS

- **Purpose:** To evaluate the bidder's capability and experience in conducting professional polygraph testing, ensuring that services are delivered competently, confidentially, and in compliance with industry standards
- **Minimum Threshold for Functionality: 50 points.** Only bidders meeting or exceeding this threshold will proceed to price and preference evaluation

	<p><b>Confidentiality</b></p> <p>The recipient of confidential information shall be careful and diligent as not to cause any unauthorised disclosure or use of the confidential information, in particular, during its involvement with SANParks and after termination of its involvement with SANParks, the recipient shall not:</p> <ul style="list-style-type: none"> <li>(a) Disclose the confidential information, directly or indirectly, to any person or entity, without SANParks' prior written consent.</li> <li>(b) Use, exploit or in any other manner whatsoever apply the confidential information for any other purpose whatsoever, other than for the execution of the contract and the delivery of the deliverables or</li> <li>(c) Copy, reproduce, or otherwise publish confidentiality information except as strictly required for the execution of the contract.</li> </ul> <p>The recipient shall ensure that any employees, agents, directors, contractors, service providers, and associates which may gain access to the confidential information are bound by agreement with the recipient both during the term of their associations with the recipient and after termination of their respective associations with the recipient, not to</p> <ul style="list-style-type: none"> <li>(a) Disclose the confidential information to any third party, or</li> <li>(b) Use the confidential information otherwise than as may be strictly necessary for the execution of the contract,</li> </ul> <p>The recipient shall take all such steps as may be reasonably necessary to prevent the confidential information from falling into the hands of any unauthorised third party.</p> <p>The undertakings set out in this clause shall not apply to confidential information, which the recipient is able to prove:</p> <ul style="list-style-type: none"> <li>(a) Was independently developed by the recipient prior to its involvement with SANParks or in the possession of the recipient prior to its involvement with SANParks;</li> <li>(b) Is now or hereafter comes into the public domain other than by breach of this contract by the recipient;</li> <li>(c) Was lawfully received by the recipient from a third party acting in good faith having a right of further disclosure and who do not derive the same directly or indirectly from SANParks, or</li> <li>(d) Is required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform SANParks of such requirement prior to any disclosure.</li> </ul> <p>The recipient shall within one (1) month of receipt of a written request from SANParks to do so, return to SANParks all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to:</p> <ul style="list-style-type: none"> <li>(a) All written disclosures received from SANParks;</li> <li>(b) All written transcripts of confidential information disclosed verbally by the SANParks; and</li> <li>(c) All material embodiments of the contract intellectual property.</li> </ul> <p>The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.</p> <p>Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licenses or relationships by furnishing of confidential information by either party pursuant to this contract.</p>
