1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- a. **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- b. **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- c. **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- d. **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- e. **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

CERTIFICATE OF INDEPENDENT BID DETERMINATION

APPOINTMENT OF A SUITABLE SERVICE PROVIDER FOR INSTALLATION AND MAINTENANCE OF A VEHICLE TRACKING SYSTEM FOR A PERIOD OF 36 MONTHS

1. Purpose of the bid

The purpose is to invite qualifying bidders for the installation and maintenance of tracking system for the municipal vehicles of Ngaka Modiri Molema District Municipality (NMMDM) on a three (03) year contract.

2. Background

There is an estimated number of 125 vehicles registered under the name of NMMDM with the possibility of acquiring more vehicles. The list includes different make and model of the vehicle and is detailed below under point 4.

3. Project Specification

The successful Service Provider need to deliver and install a tracking system with suitable equipment/devices in Council vehicles, which must have the following features:

- 3.1 Online vehicle tracking
- 3.2 Mobile and web-based application should be used to monitor vehicles online.
- 3.3 Trips managed in real-time for alerts on route deviations.
- 3.4 Multiple routes of monitoring vehicles simultaneously.
- 3.5 Area specific speed limit notification can be set up.
- 3.6 Historical information playback memory should be big enough to retrieve the video footage after more than 60 (sixty) days irrespective of the kilometres travelled.

- 3.9 Training of end-users as part of capacity building to be included in the bid. The bidder is expected to offer a maximum of three (3) free contact sessions of training per financial year as part of capacity building.
- 3.10 The service provider will be responsible for recovery due to vehicle being stolen or hijacked.
- 3.11 On-board video camera on specific vehicles to be identified by the Municipality.
- 3.12 The successful bidder shall remove the previously installed gadgets at no cost.
- 3.13 The bidder must be able to provide the relevant software for use/integrate with municipal ICT network as and when required

- 3.14 The successful service provider must be able to install the tracking devices on all municipality vehicles on as and when required basis
- 3.15 The Application (App) must bar non authorised individuals that are not allowed to drive pool vehicles from doing so.
