Phase 2: Technical/Functional evaluation criteria

In this phase all bids that met all the requirements in terms of the submitted proposal per the above set of mandatory requirements will be evaluated as follows:

Qualification Threshold – Bidders must achieve 70% per the criteria for consideration to the next phase. Bidders who fail to comply with the set minimum threshold of 70% per the technical requirements will be eliminated.

SANParks promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

This bid will be evaluated using a 2 phased system where Phase 1 will be Functionality and Phase 2 Price and B-BBEE. Bidders who fail to meet the minimum qualifying score 70% will not be evaluated further for Price and B-BBEE. The 80/20 Preference Points system as prescribed by the Preferential Procurement Regulations, 2011 will be used in Phase 2.

TERMS OF REFERENCE – APPOINTMENT OF A SERVICE PROVIDER FOR THE PROVISION OF SECURITY GUARD SERVICES AT AUGRABIES FALLS NATIONAL PARKS FOR A PERIOD OF THREE YEARS

INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

BUSINESS UNIT RESPONSIBLE FOR THE BID

Augrabies Falls National Park is part of the Arid Region within the Parks Division of South African National Parks. Augrabies Falls National Park is situated in the Northern Cape approximately 120 km west from Upington.

CONTEXT OF THIS PROCUREMENT

The purpose of this bid is to invite prospective bidders to submit a proposal for providing Security Guarding Services for SANParks. The required services will be contracted for a period of three (03) years. Bids are sought from reputable service providers that have experience and capability in the security guarding industry.

BACKGROUND

The Augrabies Falls National Park in Augrabies requires the services of a security company to provide security Grade C guards to its entrance and exit gate within the park. Guards are expected to administer, control and search incoming and outgoing persons and vehicles. The security company appointed should have the capability of increasing its guard numbers at the request of SANParks

Two areas to be serviced as follows:
