7.1 PURPOSE OF THIS DOCUMENT

Short description of the business being done, its context, and the reason for the project. Also describe the work that the SABS intends to do with the delivered product:

The High precision 3-phase power analyzers are used to measure current, voltage and calculates combined power during temperature-rise testing on a range of 3 phase electrical distribution equipment. These systems provide bandwidth from 3 MHz to 10 MHz for reliable measurement precision. The unit which was previously bought when the temperature laboratory was opened has recently burned due to double phasing from utility supply which was followed by power outage during distribution transformer testing. This resulted in three phase channels burning cards and PCB boards of the instruments which are key to measurements of the systems. Due to the failure of instrument in the laboratory we currently do not have a 3-phase power analyzer with high precision capable of measuring currents and voltages and displaying power voltage with harmonics up to the 40th. We therefore require a new system with backup additional channels system to enable us to reliable do temperature rise testing on a range of electrical distribution equipment.

The main feature of power analyzer providing the highest bandwidth on the market, the power analyzer is the ideal test and analysis tool for the development of frequency converters and lighting equipment. Our experience has shown us that a power analyzer with additional terminal is needed in the laboratory to ensure continuity of operation in cases where one terminal fails to during operation. We therefore seek to have a 3-phase power analyzer with additional channels in order to ensure testing in the temperature rise plant continues effectively without the risk on not concluding testing due to equipment failure during testing.

4. This agreement shall not apply to information which: -
 - (a) the Supplier can show had been lawfully received by it prior to disclosure under this agreement.

- (b) is in the public domain or becomes so otherwise than through breach of this agreement;
- (c) was disclosed to the Supplier by a third party who was under no obligation of confidence in respect thereof;

5. The South African Bureau of Standards retains ownership of Intellectual property rights on all material and processes relating to the service provided for and on its behalf by the supplier.
6. The Supplier shall observe its obligations under this agreement until expiry of a period of 12 months from the date of signature.
