APPOINTMENT OF SERVICE PROVIDER FOR: DEVELOPMENT OF INFORMATION TECHNOLOGY MASTER SYSTEMS STRATEGIC PLAN (MSP).

1. BACKGROUND

The Elias Motsoaledi Local Municipality (EMLM) is located in the Sekhukhune District of the Limpopo Province. It is one of four municipalities in the district. The seat of the municipality is Groblersdal.

The primary functions of the Municipal Public Accounts Committee are as follows:

1. To review and evaluate the content of the annual report and to make recommendations to Council when adopting an oversight, report on the annual report;
2. In the case of matters not finalised, information relating to past recommendations made on the Annual Report, must also be reviewed. This relates to current in-year reports, including the quarterly, mid-year and annual reports. This exercise must be geared to the remedy of problems rather than simply reporting on issues that remain persistently unresolved;
3. To examine the financial statements and audit reports of the municipality. This review must identify shifts and improvements from previous statements and reports. It must also assess the extent to which the Audit Committee's and the Auditor-General's recommendations have been implemented and seek explanation when no or ineffective actions have followed;
4. To promote good governance, transparency and accountability and value for money in the use of municipal resources;
5. To recommend or undertake any investigation in its area of responsibility, after reviewing any investigation report already undertaken by the municipality or the Audit Committee;
6. To perform any other functions assigned to it through a resolution of Council within its area of responsibility.
