Appendix B

All multi RFQ/Tender bids with value >R50k inclusive of all applicable taxes will be evaluated and adjudicated as follows:

1. First Stage - Evaluation of compliance as a qualifying criteria:

Only those Bidders that satisfy all of the Qualifying Criteria will be eligible to participate in the RFQ/Tendering Process based on mandatory conditions. Mandatory conditions include documents listed in Appendix A to be completed or submitted by bidder. Offer/ Bids that fails to meet these conditions shall be disqualified or do not satisfy all of the Qualifying Criteria will not be evaluated further.

2. Second Stage - Functionality

In this stage, bidders will be evaluated based on the functional criteria set out in this RFQ/Tender. Only those Bidders which score **85** points or higher (out of a possible score of **100** points) during the functional evaluation will be evaluated further to the next stage. Unless otherwise stipulated in RFQ/Tender default minimum score is set at 85.

Relevant Experience / Capability to execute requirement. Weight 15 points max:

- 15 points Capability / Experience in place;
- 08 points Only with Dynamics direct manpower support;
- 0 points Does not meet Capability / Experience requirements.

Bid to Specification. Weight 70 points max:

- 70 points Bid meets specification requirements;
- 0 points Bid does not meet specification requirements;

Quoted Lead Time (LT) meets requirement. Weight 15 points max:

- 15 points Meets delivery LT requirements;
- 08 points Exceed delivery LT requirement by <= 2 weeks;
- 0 points Exceeds delivery LT requirements by more than 2 weeks.

3. Third Stage - Price and Preferential points

Subsequent to the evaluation of Mandatory Criteria and Functional criteria, the third stage of evaluation of this will be in respect of Price and B-BBEE status only. Points will be allocated to bidders at this stage of the evaluation in accordance with the PPPFA Regulations, as follows:

- 80:20:** Price 80 & B-BBEE 20 for bid value >R50k to R50 million inclusive of all applicable taxes.
- 90:10:** Price 90 & B-BBEE 10 for bid value >R50 million inclusive of all applicable taxes.
