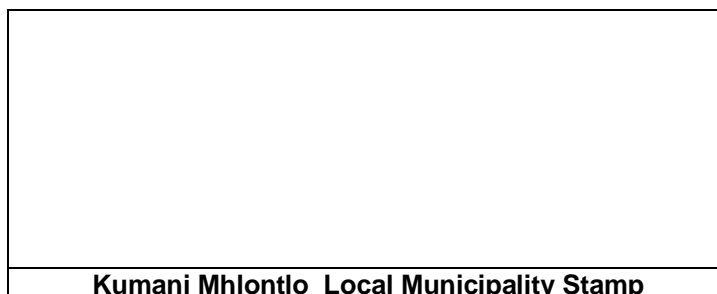

  - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) necessary.

#### **1. BACKGROUND**

Mhlontlo local municipality is one of the fastest growing municipalities in the OR Tambo District Municipality in Eastern Cape province. Along with the vast developments taking place in the area, a number of economic activities have been identified and are in control. These activities include Mining, Construction, Tourism and Agriculture. The municipality is also investing on the upgrade and development of electrical supply in order to align with the growing need catalyzed by the current developments.
