

Specifications for glazing of Hall 5 & 6

1. Background

This specification is for the refurbishment of the existing cottage window panes in Hall 5 & 6 at the ARC-NRE facility at Silverton. The refurbishment is meant to protect the halls from being entered by birds and also improve the face of ARC in case we have external visitors. The requirements for refurbishment are detailed below under specification.

2. Scope of work

This scope of work covers glazing, glazed windows, glazing panels in windows, other glazed protective systems, and non-attached window retrofit systems used in buildings that may be subjected to intentional or accidental explosions. The scope covers the whole window frame, opening, and closing mechanisms, and the building structural steel behind the glass frames.

3. Specifications

The windows' height is the following:

3.1. Painting of all steel

- All rusted steel must be sanded with a flap disk that is mounted on an angle grinder after the old glass panes are removed.
- All Steel must be clean, dry, firm and dust free.
- Brush painted (No spray painting) with similar or equivalent to one coat metal care etch primer (SNK 100) thinned with similar or equivalent to Coastcote Thinners (SNK 7). Strictly to manufacturer's specification and instructions.

- Minimum paint thickness 20µm.
- Color: Red
- Brush paint one coat of paint similar or equivalent to Plascon Enamel Doors and trims (NY 1/g).
Strictly to manufacturer's specification and instructions
Color: Brilliant Green

3.2. Window opening mechanisms

- Ensure all window opening mechanism is in a good working condition.
- Replace 12 ropes with 6mmx3m nylon ropes.
- The rope length must be such that the opening mechanism can be operated from minimum 1.5m above floor level height.

3.3. Glass

- All glass to be 3mm Monolithic annealed clear glass.
- All glass must be cleaned after installation.
- Putty must be SANS 680 certified.
- Allow the putty to dry before painting.
- The glazed putty should not be left unpainted for more than 17 days.
- Putty must be painted same as steel specification

4. Standards & dimensions

- Descriptions (prices) of glass shall be deemed to include putty, springs, pegs or clips and removal , and the prefixing of glazing beads where applicable.
- All work to comply with the National Building Regulations & Building Standards Act SANS 10400 1990 (or latest). Local council requirements & all relevant specifications and codes are to be adhered to.
- The glazing and fixing of glass in buildings shall be carried out in strict accordance with SANS 10137
- Indicated dimensions to be taken in preference to scaling. Overall dimensions (external) to take precedence.
- All dimensions, levels and heights to be checked on site and any discrepancies to be reported to the Engineers before any work takes place.
- All dimensions on drawings and documents to be checked before commencing of any work and/or compiling of quotes.

5. Compulsory Requirements

5.1. Reference

- Three reference letters that indicate you have **successfully completed similar work**. The letter should be on a **letterhead of the company where services were provided with the value of work completed**.

5.2. Construction Industry Development Board

- The contractor must be certified as CIBD 2 GB/2 SG

5.3. Warranty

- The work must carry a warranty of one year from date of final commissioning at each site.
- The contractor shall be responsible for all glass broken, scratches, damages or defective during project execution
- Maintenance services must be provided within 48 hours of a request.

5.4. Site Briefing

- Site briefing compulsory

6. Contingency

- A contingency amount of 10% of the quoted price must be included in the quotation.
- **NOTE:** The contingency amount belongs to ARC therefore it's within our right to use.
