### **EXPRESSION OF INTEREST TO SUITABLE PARTIES TO DEVELOPMENT AND IMPLEMENT A TOWNSHIP DEVELOPMENT MODEL ON PORTION 39 OF FARM KLIPBANK 26 JS (GROBLERSDAL TOWN, LIMPOPO).**

#### **1. PURPOSE**

- The Elias Motsoaledi Local Municipality (EMLM) is requesting proposals from suitable and interested parties to finalize the township establishment process (i.e. registration of layout plan at the Surveyor General's office, opening of a township register and township proclamation), development and implementation of a township development model that will enable the Municipality to realize its constitutional enshrined obligation(s) through availing housing options that are tailor made for the population demographics of the Elias Motsoaledi Municipality population, particularly (but not limited to) their socio- economic status. The prospective service provider will also be expected to implement the initiated township development model and also install infrastructure services in a form of water, sewer, electricity, roads, storm water services.

#### **2. BACKGROUND**

- Elias Motsoaledi Local Municipality is constitutionally obliged to create conducive environment for the realization of sustainable human settlement(s) hence the process at hand.
- A process of a township establishment on portion 39 of farm Klipbank 26 JS was initiated by the Municipality for the development of an integrated human settlement concept. All necessary legislatively prescribed processes were undertaken through a township establishment process. A layout plan of 1144 stands was an attribute of the latter process.
- Consequently, the Municipality could not conclude the township establishment process. The process of layout registration with the surveyor general, opening of township register and township proclamation are still outstanding.
- Another important aspects that still need to be addressed is the installation of civil engineering services in a form of water, sewer, electricity, roads and storm water services.

### **3. AIMS AND OBJECTIVES**

The key objectives for invitation of suitable and interested parties for development and implementation of township development model on portion 39 of farm Klipbank 26 JS are as follows:

- To create and foster sustainable human settlement.
- Increase Municipal revenue base.
- To curb sprawl and land invasion.
- To enable Groblersdal town to discharge its duties as a Provincial Growth point.

### **4. SCOPE AND FUNCTIONS**

- The appointed service provider will be expected to execute the following:
  - 4.1 Develop a township development model.
  - 4.2 Present the model to the Municipality/demonstrate how the developed model will function and ultimately benefit both the parties (Service providers & local community) and the municipality.
  - 4.3 Implement the developed township development model.
  - 4.4 Registration of the Layout plan at the Surveyor General's Office.
  - 4.5 Opening of township register.
  - 4.6 Township proclamation.
  - 4.7 Installation Civil engineering services (i.e. water, sewer, electricity, roads, and storm water services).

### **5. SKILLS TRANSFER**

- The prospective service provider will be expected to transfer necessary skill(s) to relevant Municipal personnel(s).

### **6. APPOINTMENT AND DURATION**

- The prospective service provider will be appointed for three (3) years or less.

### **7. REPORTING RELATIONSHIP**

- The prospective service provider will report to the Accounting Officer or a person delegated by the Accounting Officer.
- The prospective service provider will be expected to provide formal written monthly reports
- The prospective service provider will be expected to provide formal written reports and soft copies.

## **8. Intellectual Property Rights**

8.1. All copyright and intellectual property rights that may result as consequence of the work to be performed will become the property of the EMLM.

8.2. All information handed to service provider for execution of work at hand must handed over to EMLM in a format that it had been originally relayed to the Service provider.
