#### **3.1.1 DESCRIPTIONS OF WORKS**

The duties to be performed by the Consultant is to implement an accredited Safety and Security SETA (SASSETA) Learnership Programme within Nkangala District Municipality for 150 Learners for a period of three Financial Years (2026/2027, 2027/2028 And 2028/2029). The learners shall be recruited from the six local municipalities that fall within Nkangala District Municipality namely, Dr. JS Moroka Local Municipality, Thembisile Hani Local Municipality, Victor Khanye Local Municipality, Emalahleni Local Municipality, Steve Tshwete Local Municipality and Emakhazeni Local Municipality. The advertisement for recruitment of learners shall be done through local radio stations, newspapers and using available social media platforms such as WhatsApp, Facebook, Instagram, Tweeter etc. and in collaboration and consultation with Nkangala District Municipality: The 150 learners shall be appointed from six local municipalities based on unemployment rate and demographics as per table below for a period of three financial years, with 50 learners in each financial year:
