SECTION A2

SCOPE OF WORKS

1. INTRODUCTION AND BACKGROUND

“Enabler 1” focuses on priorities related to the establishment of an integrated and comprehensive information management and communication system for disaster risk management. More specifically, it addresses the information and communication requirements of each KPA and Enablers 2 and 3 and emphasises the need to establish integrated communication links with all disaster risk management role players at National, Provincial and Local government sphere.

The Municipality needs a fully functional communication and information system which shall enable the achievement of the KPAs and become a repository of information as a Disaster Management Centre. Information pertained in our system must include all the declared disasters in our District which includes information on beneficiaries and the assistance that was provided. The expectation from the system is to ensure our ability to support other departments in their service delivery areas by having our risk profile available in a touch of a button. It will not only benefit the Disaster Management Centre but the entire Municipality as the system must be compatible to the Municipalities GIS and connect all activities being implemented and activities planned so that they can be informed by the risk profile.

The following is the relevant legislative prescript which guide the implementation Disaster Management Centre’s at the Municipality;

- ✓ The Constitution of South Africa (Chapter 7, section 152 (d))
- ✓ Disaster Management Act 57 of 2002 as amended
- ✓ Fire Brigade Services Act 99 of 1987 as amended

2. LOCATION

Supply and installation of the Disaster Management Centre Communication and Information System at the Harry Gwala District Municipality Disaster Management Centre;

3. OBJECTIVES

The objective of this project is to appoint competent Service Provider for the Supply and Installation of the Disaster Management Centre Communication and Information System for Harry Gwala District Municipality in order to meet the obligations highlighted in the Disaster Management Act 57 of 2002, which requires the following:

- ✓ To ensure that Harry Gwala District Municipality complies with Chapter 5 section 42 of The Disaster Management Act, which requires the Municipality to implement the Disaster Management Framework.
- ✓ To implement The Disaster Management Framework's Enabler 1, which requires that a Municipality's Disaster Management Centre must have a comprehensive information and communication system.
- ✓ To ensure that the Harry Gwala District's Disaster Management Centre has a fully functional communication and information system that will enable swift and effective integration of information and dissemination of information to relevant role players.
- ✓ To ensure that there is appropriate risk reduction, prevention and mitigation of incidents and disasters through the dissemination of early warning messages to stakeholders and communities.
- ✓ To enable The Disaster Management Centre to respond swiftly to incidents, coordinate response measures and activate a JOC whenever necessary.
- ✓ To enable the Disaster Management Centre to capture, collate and produce reports on incidents swiftly within the stipulated timeframe of reporting deadlines and for the purposes of disaster declaration.

- ✓ To enable the Harry Gwala District Municipality to deliver a safe and reliable IT infrastructure, that provides adequate level of data availability and integrity.

4. SCOPE AND EXTENT OF WORK

1. Task breakdown

- 1.1. Supply and Installation of the Disaster Management Centre Communication and Information System as per the specification hereunder,
- 1.2. Provide relevant training for the Disaster Management personnel including the IT personnel;
- 1.3. Provide skills transfer to the Disaster Management personnel including the IT personnel;

2. Technical Specifications

Enabler 1 focuses specifically on priorities related to the establishment of an integrated and comprehensive information management and communication system for disaster risk management. It is a requirement to have an information and communication system for Disaster Risk Management to establish integrated communication links with all disaster risk management role players in national, provincial and municipal spheres of government.

Functional requirements

- a) The integrated information and communication system must address all the key performance areas (KPAs) of the National Disaster Management Framework of 2005.
- b) The system must be extensible to enable integration with other applications such as the national and provincial disaster management information systems, fire and rescue services, traffic management systems, emergency management services,

SAWS and meteorological and hydrological early warning systems which will allow for the automated receipt of early warnings and incident reports.

- c) The Disaster Management Information Systems must further be designed to facilitate the integration of digital technology for the disaster management environment. It must be a configurable platform that integrates mobile data collection tools with web data management, workflow and web GIS to support disaster management role-players.
- d) The system must make provision to facilitate Response & Recovery Operations supporting a co-ordinated and integrated response and recovery effort, encompassing the dissemination of early warnings, guidelines for the assessment, classification, declaration and review of a disaster, establishing standardized and regulated relief measures and ensuring integrated rehabilitation and reconstruction activities conducted in a developmental manner.
- e) The system must be able to integrate with 3rd party applications and other municipal systems in support of a fully integrated approach to both emergency and non-emergency functions required of the municipality

SECTION A3

EXPECTED OUTCOMES FOR HARRY GWALA DISTRICT MUNICIPALITY

1. DEFINITIONS

- 1.1 **"all applicable taxes"** includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;
- 1.2 **"B-BBEE"** means broad-based black economic empowerment as defined in section 1 of the Broad Based Black Economic Empowerment Act;
- 1.3. **"B-BBEE status level of contributor"** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 1.4 **"bid"** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 1.5 **"Broad-Based Black Economic Empowerment Act"** means the Broad-Based Black Economic empowerment Act, 2003 (Act No. 53 of 2003);
- 1.6 **"comparative price"** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 1.7 **"consortium or joint venture"** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 1.8 **"contract"** means the agreement that results from the acceptance of a bid by an organ of state;
- 1.9 **"EME"** means any enterprise with annual total revenue of R5 million or less;
- 1.10 **"Firm price"** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the supplier and demonstrably has an

- influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 1.11 **"functionality"** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 1.12 **"non-firm prices"** means all prices other than "firm" prices;
- 1.13 **"person"** includes a juristic person;
- 1.14 **"rand value"** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 1.15 **"sub-contract"** means the primary supplier's assigning, leasing, making out work to, or employing, another person to support such primary supplier in the execution of part of a project in terms of the contract;
- 1.16 **"total revenue"** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the Government Gazette on 9 February 2007;
- 1.17 **"trust"** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 1.18 **"trustee"** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.
- 1.19 **"PSP"** Professional Service Provider (The Bidder) undertakes to bring onto site without additional cost to the Employer any additional plant not listed but which may be necessary to complete the contract within the specified contract period.

SECTION A4

SPECIAL INSTRUCTIONS AND NOTICES TO SERVICE PROVIDERS REGARDING THE COMPLETION OF BID FORMS

PLEASE NOTE THAT THIS BID IS SUBJECT TO TREASURY REGULATIONS 16A ISSUED IN TERMS OF THE MUNICIPAL FINANCE MANAGEMENT ACT, 2003, THE HARRY GWALA DISTRICT MUNICIPALITY SUPPLY CHAIN MANAGEMENT POLICY FRAMEWORK.

1. Unless inconsistent with or expressly indicated otherwise by the context, the singular shall include the plural and visa versa and with words importing the masculine gender shall include the feminine and the neuter.
2. Under no circumstances whatsoever may the bid forms be retyped or redrafted. Photocopies of the original bid documentation may be used, but an original signature must appear on such photocopies.
3. The supplier is advised to check the number of pages and to satisfy himself that none are missing or duplicated.
4. Bids submitted must be complete in all respects.
5. Bids shall be lodged at the address indicated not later than the closing time specified for their receipt, and in accordance with the directives in the bid documents.
6. Each bid shall be addressed in accordance with the directives in the bid documents and shall be lodged in a separate sealed envelope, with the name and address of the bidder, the bid number and closing date indicated on the envelope. The envelope shall not contain documents relating to any bid other than that shown on the envelope. If this provision is not complied with, such bids may be rejected as being invalid.
7. All bids received in sealed envelopes with the relevant bid numbers on the envelopes are kept unopened in safe custody until the closing time of the bids. Where, however, a bid is received open, it shall be sealed. If it is received without a bid number on the envelope, it shall be opened, the bid number ascertained, the envelope sealed and the bid number written on the envelope.
8. A specific box is provided for the receipt of bids, and no bid found in any other box or elsewhere subsequent to the closing date and time of bid will be considered.

9. No bid sent through the post will be considered if it is received after the closing date and time stipulated in the bid documentation, and proof of posting will not be accepted as proof of delivery.
10. No bid submitted by telefax, telegraphic or other electronic means will be considered.
11. Bid documents must not be included in packages containing samples. Such bids may be rejected as being invalid.
12. Any alteration made by the supplier must be initialled.
13. Use of correcting fluid is prohibited
14. Bids will be opened in public as soon as practicable after the closing time of bid.
15. Where practical, prices are made public at the time of opening bids.
16. If it is desired to make more than one offer against any individual item, such offers should be given on a photocopy of the page in question. Clear indication thereof must be stated on the schedules attached.

SECTION B
REGISTRATION ON THE HARRY GWALA DISTRICT MUNICIPALITY SUPPLIERS DATABASE

1. In terms of the Harry Gwala District Municipality Supply Chain Management Policy Framework, all suppliers of goods and services to the Municipality are required to register on the Suppliers Database.

3. If a business is registered on the Database and it is found subsequently that false or incorrect information has been supplied, then the Municipality may, without prejudice to any other legal rights or remedies it may have;
 - 3.1 De-register the supplier from the Database,
 - 3.2 Cancel a Bid or a contract awarded to such supplier, and the supplier would become liable for any damages if a less favourable quotation is accepted or less favourable arrangements are made.
4. **The same principles as set out in paragraph 3 above are applicable should the supplier fail to request updating of its information on the Suppliers Database, relating to changed particulars or circumstances.**
5. Application for registration must be submitted to the Harry Gwala office at Harry Gwala District Municipality. **IF THE SUPPLIER IS NOT REGISTERED AT THE CLOSING TIME OF BID, THE SUPPLIER IS REQUIRED TO SUBMIT A COPY OF THE REGISTRATION APPLICATION FORM, TOGETHER WITH THE BID DOCUMENTATION, TO THE RESPECTIVE DEPARTMENT INVITING BIDS.**

STAGE 2: POINTS AWARDED FOR PRICE AND PREFERENCES

2.2.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

80/20

P_s = Points scored for comparative price of bid under consideration

P_t = Comparative price of bid under consideration

P_{\min} = Comparative price of lowest acceptable bid

NB: The 80/20 System will be used for this Bid.

2.2.2 POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTION (PREFERENCES)

In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

2.2.1 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification

Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.

- 2.2.2 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 2.2.3 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 2.2.4 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 2.2.5 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 2.2.6 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-supplier is an EME that has the capability and ability to execute the sub-contract.
- 2.2.7 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.

5. SUB-CONTRACTING
