1. PURPOSE

The KwaZulu-Natal Growth Fund Agency (KZNGFA) invites quotations for appointment of a service provider to provide 2 (two) outdoor branded signages for the KwaZulu-Natal Growth Fund Offices.

2. OBJECTIVE

Outdoor building signage is an effective way to brand and draw attention to the organization. These signs are ideal for high-traffic areas, making the business easy to find from the street or the road. It must be noted that the building is visible from the M4, Stamford Hill, Durban.

Bidders must be able to design and install two (2) illuminated outdoor 3d cut out signages for the exterior building. The signage must comply with the following specifications:

Bidders must use the attached plans and submit a proposal, design and artwork layout. Signage designs must be in the following parameters:

Approximately 841 x 1189 mm signage for the front entrance of the building at the office park facing the main gate.

Approximately 841 x 1189 mm signage for side entrance to KZNGFA.

Signage must have a lightbox switch to turn on and off as required. Signages must light up in the evening and save electricity during the day.

Materials mainly used acrylic, stainless steel foam, and aluminum.

The appointed service provider will be responsible for installing signage and hiring all the additional equipment needed to erect the signage (building height is approximately 15 -20 meters).

3. BACKGROUND

KZNGFA is an Agency, established and capitalised by the Provincial Government to provide debt and equity. The main objective of the KZNGFA is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

2.1 Procurement Philosophy

It is the policy of KZNGFA, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;

- c) The development, promotion and support for the moral values that underpin the above, in terms of KZNGFA Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KZNGFA.

The KZNGFA wishes to engage with service providers who are equally committed to maintain high quality services and better pricing.

4. SCOPE OF SERVICES REQUIRED

Procurement of the services of a suitably qualified and experienced service provider for the supply and installation of 2 (two) light box signage at the front and back of the KZNGFA Building that is leased in the Kingsmead Office Park.

The following technical aspects is required: -

- 2 x Light boxes with full colour logos on durable
- Measurements are estimated at 841 x 1189 mm (suppliers will need to measure for accuracy and include that in their quoting)
- All Weather Resistance / waterproof material
- Material: Acrylic White Plastic with LED backlight
- 99 Percent UV Protection
- LED Back Light
- Include KZNGFA Logo (KZNGFA will provide the high-resolution graphics)
- The vinyl used must be durable and have guarantee of at least five (5) years.
- 1-year warranty on the lightbox electrical mechanisms

The service provider must:

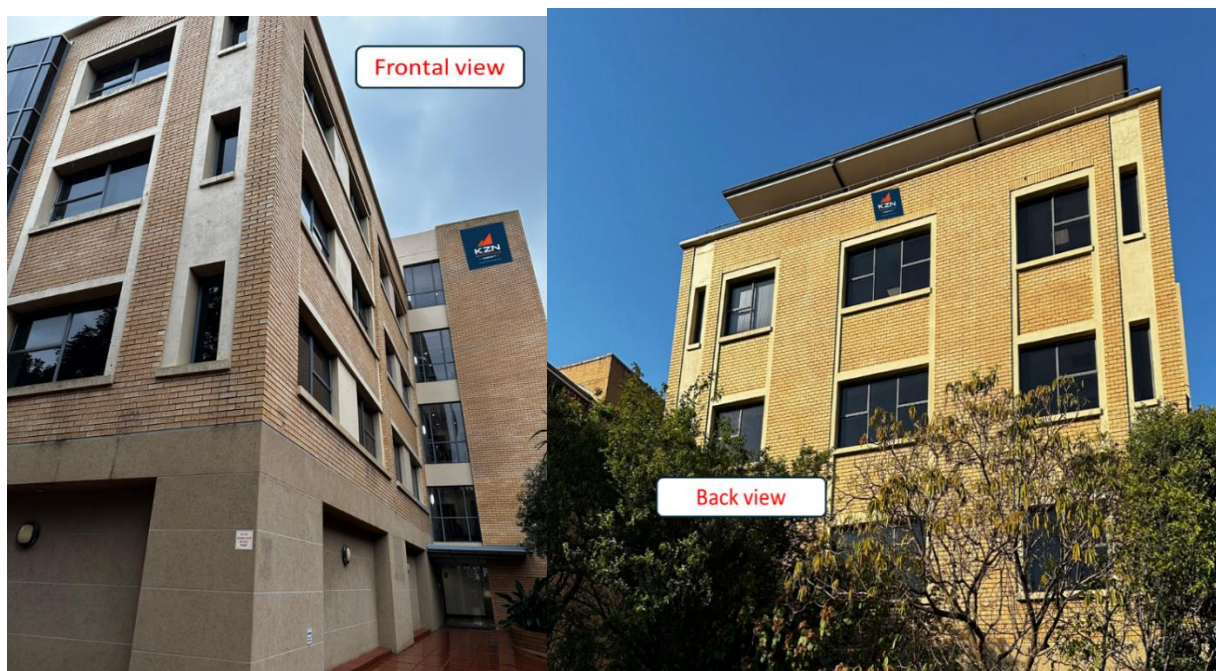
- Demonstrate their ability to provide and install high-quality branding for organizations in both the public and private sectors.
- Have at least two (2) years of electrical/ lightbox installation experience.

Safety Requirements

The following will be required on the appointment of the supplier as part of the safety requirements, and submission of the health and safety file for approval;

- Compile a health and safety plan for the KZN regions.
- Applicable legal appointment letters and agreements.
- A valid letter of good standing from the Department of Labour (COIDA).
- Wear personal protective equipment at all times.
- Use of proper tools and equipment for the works.

- Provision for working at heights, with competent staff to operate either cherry pickers, erect and dismantling of scaffolding where applicable.



5. DURATION

Production and Installation within 1 month and 12 months for maintenance and cleaning of the lightbox.

6. AWARD OF THE RFQ

KZNGFA is not obliged to accept and award this RFQ to the lowest bidder or any other bidder.

6.2.1.2 Provide proof of public liability cover of a minimum R 1 000 000.00.

All bids duly lodged as specified in this RFQ will be examined to determine compliance with the mandatory requirements and conditions. Failure to provide any mandatory information as requested above will result in the submission being deemed non-responsive.

6.2 FUNCTIONALITY EVALUATION

Scores will be tabulated to 50 points. Respondents must score 35 points (70%) and over to be assessed on their financial offer and preference score. The allocation of points for the evaluation of quality / functionality is set out in Table 1 below:

Ps = Points scored for price of tender under consideration

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

80/20

or

90/10

$$Ps = 80 \left(1 + \frac{Pt - P_{max}}{P_{max}} \right) \quad \text{or} \quad Ps = 90 \left(1 + \frac{Pt - P_{max}}{P_{max}} \right)$$

Where

Ps = Points scored for price of tender under consideration

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

(b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
