1.	We refer to RFQ No. 10421 for the appointment of a Professional Engineering Consultant for the replacement of Airfield Ground Lighting at George Airport. We note that the requirements for the Lead Electrical Engineer specify that at least one completed project involving Airfield Ground Lighting (AGL) must have been completed within the past 15 years. Considering the specialized nature of AGL projects and the limited number of large-scale projects in this sector, we respectfully request that the eligibility period for completed projects be extended from 15 years to 20 years. This extension would allow experienced professionals who have successfully delivered relevant AGL projects slightly older than 15 years to demonstrate their expertise, ensuring a fair and comprehensive evaluation of Key Staff.
