1. You are kindly requested to submit a written quotation to the Agricultural Research Council as per below or attached terms of reference (TOR).

SCOPE OF WORK:

1) BLOCK B4. Removal of vines (stumps and roots) and upright trellis poles in Block B4. Wires and slanting split poles as well as irrigation components will be removed by Nietvoorbij farm team. The area is ± 1.25 hectares with ± 8700 vines (29 rows). These vines are from crosses and not grafted and were planted 0,4 m apart. Most are smaller than mature commercial vines.

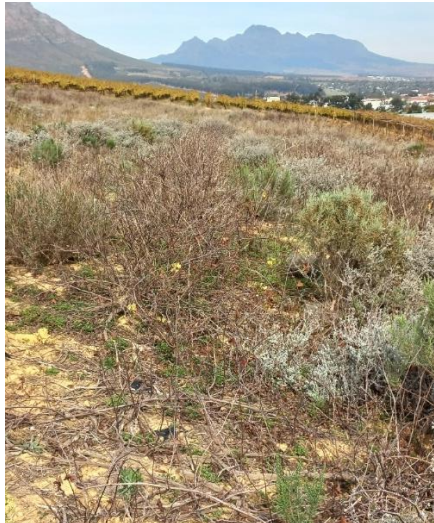
The image below depicts the area to be cleared (part of a vineyard) in Block B4. Uprooted vines and poles must be moved to the open area next to the R44.



Upper parts of the vines were already removed and only stumps and roots need to be removed from the soil in Block B4 (see photo below).



2) BLOCK G6. Removal of rootstock vines (stumps, shoots and roots) in Block G6. Trellis already removed. The images below depict the area to be cleared of old rootstocks and other vegetation in Block G6. The area is $\pm$ 0.75 hectares (26 rows).

- 1.1 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.2 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
